Rules

- 🐾 Dogs must have current license and vaccinations and over the age of four (4) months. You will need to provide proof of licensing and current rabies ID tag upon request by any City official. (TN Code Annotated, §§ 68.8.101-68.8.114, MC Title 10-202)
- 🐾 Your dog must be off-leash while inside the K-9 Korral. Please remove any pronged, spiked or choke collar from the dog within the double gated entry prior to entering the park. However, your dog must wear a collar with identification at all times inside the K-9 Korral.
- 🐾 Your dog must be restrained by a substantial chain or leash not exceeding eight (8) feet in length except while inside the fenced area of the K-9 Korral. (MC Title 10. 205-215)
- 🐾 Do not bring strollers, carriages, baby carriers, bicycles, scooters, children's toys, food, dog toys, dog treats or dog food into the park. (Tennis balls are okay).
- 🐾 Bring no more than three (3) dogs into the K-9 Korral at any one time per owner.
- 🐾 Beware: K-9 Korral is not separated by size; therefore, please know your dog's limitations.
- 🐾 Pick up and properly dispose of your dog's feces both in and around the K-9 Korral.
- 🐾 Remain with your dog (s) at all times. You are solely responsible and liable for any and all injuries and/or damage caused by your dog.

Cautions and Courtesies

- 🐾 Aggressive dogs prohibited. (MC Title 10. 206)
- 🐾 Smoking is not permitted fifty-feet (50') from the surrounding area of the K-9 Korral.
- 🐾 Do not bring a dog with a known communicable disease, injury or recovering from an injury.
- 🐾 Handlers must control excessive barking. (MC Title 10. 211)
- 🐾 Do not bring a dog in heat.
- 🐾 Fill holes and stop dogs from digging anywhere within the play area.
- 🐾 Know your abilities and your dogs. Children who are too young to recognize the risks associated with using this facility should be supervised by an adult. CAUTION: Children who run may trigger herding instinct in herding dogs.
- 🐾 No other animals are allowed in the park.
- 🐾 No person shall conduct any activity which may be or create an immediate danger to the public health, safety, and welfare. Such activity must cease immediately when asked to do so by a City official.
- 🐾 Do not leave dogs unattended. Abandonment of animals is prohibited. (TN Code Annotated §§ 39.14.202(a)3)
- 🐾 Do not enter the K-9 Korral when it is closed.

City Regulations

- 🐾 You are not allowed to operate or conduct a business within the park, unless permitted by the City. Organized events require a special event permit which may be obtained through the Franklin Parks Department.
- 🐾 City of Franklin Park Staff shall enforce all park rules and reserves the right to restrict entry to the dog park.
- 🐾 K-9 Korral is closed from Dark till Dawn and may be closed or adjusted, as conditions require.
- 🐾 Any person found in violation of any of the provisions of this municipal code, shall be guilty of a misdemeanor and shall be fined not less than \$10 nor more that \$50. (TN Code Annotated §Title 39 Chap. 14) (MC Title 10, Ch.2 :201-215)
