


Friday, February 2, 2018

The Franklin Fire Department is offering two CPR classes in honor of American Heart Month. These non-certification classes are for those who want to learn CPR and do not need a CPR course completion card to meet a job requirement. Participants will learn how to perform CPR, use an AED, and relieve choking in adults, children and infants. The classes are recommended for those who are 12 years of age and older. According to the American Heart Association, 70 percent of Americans may feel helpless to act during a cardiac emergency because they do not know how, or lack the confidence, to administer CPR. This statistic could hit close to home, because AHA says home is where 88 percent of cardiac arrests occur. Put very simply, the life you save with CPR is mostly likely to be someone you love. Have you always wanted to try out the "Jaws of Life," break down a door or ride in a platform at the top of a 100' aerial ladder truck? Then the Franklin **Fire Department's Citizens' Fire Academy** is for you! During this eight-week, hands-on program, participants ride along on fire calls and fire inspections, learn how to operate hose lines and other fire equipment, perform vehicle extrication, search and rescue, learn CPR and ride in a platform at the top of a ladder truck. Live firefighting is the course finale, where participants use all of the knowledge and skills they've learned to extinguish fires and get everyone out of the building safely. The group meets on Thursday evenings from 6 – 9 p.m. at the Franklin Fire Training Center on Century Court (with complimentary dinner provided from 5:30 - 6 p.m.). There is no cost for the program.
