Cost of Living Increases for Retirees

<u>Purpose</u>

The purpose of this agenda item is to consider approval of a cost-of-living increase for existing recipients of benefits from the City of Franklin Pension Plan.

Background

The Board of Mayor & Aldermen has the authority to approve adjustments to the benefit levels of those retired under the City Pension Plan. For several years, the Board has followed the policy for cost of living increases used by the State of Tennessee Consolidated Retirement plan. The parameters used previously call for a cost-of-living increase that matches the increase in the "core" Consumer Price Index (CPI) for all items, excluding food & energy, subject to a 3% maximum. The measure is to be evaluated based on the April CPI, which will be available on May 15th.

Financial Impact

No impact to General Fund. Pension benefits are paid from the investment earnings of the Pension Fund.

Options

Adopt the recommendation of the Pension Committee and Finance Committee, suggest an alternative rate of increase, or take no action. Recent Board actions have been to make adjustments to the pension benefit of retirees (or their surviving spouses) that are generally in line with increases in consumer price levels.

Recommendation

Staff recommends that the Board continue the policy and approve a 2.3% increase, based on the April, 2012 CPI (Series ID: CUUR0000SA0L1E).
