SUBJECT: **Consideration of Bid Award for the Street Department Annual Contracts**

Purpose

The purpose of this memorandum is to provide information to the Board of Mayor and Aldermen (BOMA) for the consideration of Bid Awards for the Street Departments Annual Contracts for Fiscal Year 2012-2013

Background

On May 23, 2012 Annual Contract Bids were publicly opened and read aloud for the following contracts:

1. Called Bonds – COF Contract No. 2012-0043
2. Concrete Curb & Sidewalk – COF Contract No 2012-0044
3. Maintenance & Drainage Stone – COF Contract No. 2012-0045
4. Roadway Repairs and Resurfacing – COF Contract No. 2012-0046
5. Stormwater & Drainage Improvements – COF Contract No. 2012-0047

City staff provided estimated quantities allowing the contractors to competitively bid the contracts. Individual work orders and construction schedules will be established for each project based on the unit prices established as part of the bid process. All unit prices shall be for a one-year period with the possibility of extending the contract for up to three years provided the bidder and City agrees to the extension.

As part of the Called Bonds Contract, Roadway Repairs and Resurfacing Contract and the Stormwater & Drainage Improvements Contract we have included TDOT Special Provision Regarding Price Adjustment for Bituminous Material (Asphalt). This special provision allows prices to be adjusted to compensate for increases and decreases in the contractor's bituminous material cost associated with Roadway Resurfacing Projects.

Financial Impact

There is no financial impact associated with the award of the annual contracts. All funds are approved as part of the Street Departments Annual Budget and projects accomplished as needs arise throughout the year for the various contracted items' maintenance, repairs, or improvements.
