Sewer Availability Request for The Carters Creek Pike Residential Project located at 1845

Carters Creek Pike (Map 74 Parcel 34).

Purpose

The purpose of this memorandum is to forward to the Board of Mayor and Aldermen (BOMA) a request for Water and Sanitary Sewer availability for the property located at 1845 Carters Creek Pike (Williamson County Map 74 Parcel 34).

Background

A request for Water and Sanitary Sewer Availability for Carters Creek Pike Residential (Map 74, Parcel 34) was submitted on 5-31-2012. This request is for 156 SFUEs (single family residential units). The property is located adjacent to the city limits and within the Urban Growth Boundary. The property is located in the West Basin and is located 300' from the Carters Creek Pike Pump Station. Currently this pump station discharges in the Central Franklin Basin and is serviced by the Sharps Branch Interceptor Sewer. Water service is approximately 1,500 LF North of the property requiring the applicant to extend the main line and provide a loop connection.

It has been the Board's policy to require properties located outside of the City limits and requesting more than 1 SFUE to also require annexation. A formal annexation request has not been presented at this time. It was decided to bring this forward to the CIP Committee as the applicant would like to understand the City's requirements prior to moving forward with annexation.


Financial Impact

Recommendation

Prior to issuing availability, it is recommended, to require the applicant to enter into an agreement with the City to pay for a Water and Sewer study. This study will analyze the existing infrastructure and interceptor located in the West Basin and the Carters Creek Pike Pump Station. The estimated cost is between \$20,000 and \$30,000. At the completion of this study City staff will be able to determine availability and the necessary upgrades to provide service.
