1. Call to Order

Alderman Clyde Barnhill, Chair, called the meeting to order at 4:00 p.m.

2. Approval of Minutes

Alderman Bransford moved to approve the May 10, 2012 minutes as presented. Seconded by Alderman McLendon. Motion carried unanimously.

3. Consideration of Amendment No. 2 to Add Construction Administration to the Professional Services Agreement (COF Contract No. 2011-0032) with URS for the Green Branch Stream Project in an Amount Not to Exceed Cost of \$17,800.00

David Parker, City Engineer/CIP Executive Paul Holzen, Engineering Director

URS is finalizing the design. Staff feels help is needed with construction administration. The work is for stream restoration and bank stabilization because of the 2010 flood.

Alderman Bransford moved to approve Amendment No. 2 and forward recommendation to BOMA. Seconded by Alderman Martin. Motion carried unanimously.

4. Consideration of Sanitary Sewer Availability Request for Deerfield Section 2, Lot 1 (100 Deerfield Lane)

Paul Holzen, Engineering Director

Doug Majors, Majors Construction, was present on behalf of the property owner who wants to build an addition to the home. Staff recommendation is to allow the request since it is for one SFUE and it would connect to the existing sewer system directly south or west of the property.

Eric Stuckey explained it is a straightforward connection to the City's line to the south and west and will

not impact other property owners.

Alderman Martin asked what if other property owners want to do the same thing. Paul Holzen responded that it would be cost prohibitive for others in the addition to do so. Alderman Martin was concerned because of the policy not to grant sewer without annexation.

Mr. Majors advised the septic field has failed and there is no soil suitable for a backup field; thus, the property owner cannot have a new septic system on the property.

Alderman McLendon moved to approve sewer availability for one SFUE for 100 Deerfield Lane and forward recommendation to BOMA. Seconded by Alderman Bransford. Motion carried 3-1 with Alderman Martin voting no.

5. Consideration of RESOLUTION 2012-32; A Resolution Establishing Names for Unnamed Streams in Franklin that Drain into the Harpeth River or its Tributaries

Crystal Bishop related all proposed stream names were carefully researched as to historical significance. Alderman Bransford's request to name a stream for the Rev. William Scruggs in the Old Carter Creek Road area was granted. Mr. Holzen said the next step is to make application to the U.S. Board on Geographical Names (BGN). Staff has listed names for 41 streams. This item will be on the June 21 BOMA agenda. Once approved the application can be submitted to the BGN. The process will take 3-6 months to complete.

Alderman Bransford moved to approve and forward recommendation to BOMA. Seconded by Alderman McLendon. Motion carried unanimously.

6. Consideration of the Construction Contract Award to North State Environmental, Inc. for the Harpeth River Restoration Project (COF Contract No. 2012-0017) in the Amount of \$441,995.83

This project is also known as the low-head dam removal agreement with the Harpeth River Watershed Association. TDEC will provide \$189,000.00 for the dam removal, plus \$120,600.00 from the U.S. Fish & Wildlife Services, leaving \$321,395.83 as the projected cost to the City.

Alderman McLendon moved to approve and forward recommendation to BOMA. Seconded by Alderman Martin. Motion carried unanimously.

Looking at options and changes to the agreement to make sure the project is done as intended.
