

ORDINANCE NO. 2012 – 34

WHEREAS, the City Charter, Article VIII, provides for adoption of an annual budget for departments of the City of Franklin, and

WHEREAS, an annual budget process appropriating funds to the various departments and divisions of the City government for the fiscal year beginning July 1, 2011 has been completed in accordance with state law and local ordinances,

NOW, THEREFORE BE IT ORDAINED, by the Board of Mayor and Aldermen of the City of Franklin, Tennessee:

SECTION I: That the annual budget for the City of Franklin for the Fiscal Year 2011-2012 shall be amended and does allocate and appropriate additional funding as follows:

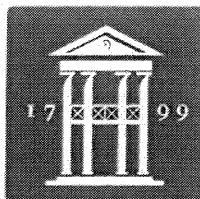

RE: Budget Amendments based on Fiscal Year 2012 Third Quarter activity

Purpose

The purpose of this item is to amend the Fiscal Year 2011-2012 Budget to account for activities or conditions arising since passage of the original budget.

Background

Rather than bringing a myriad of budget amendments at numerous Board meetings, staff recommended that we bring possible budget amendment to the Budget & Finance Committee on a quarterly basis. Budget amendments for July through September were presented at the November 2011 meeting; October through December in February 2012; January through March here in May 2012; and April through June in September or October 2012.

The attached page contains the proposed amendment(s) arising from the January through March time frame.

The amendments are as follows:

1. Transfer of acquisition cost, \$2,354,788, of the Public Works Facility from General Fund to Capital Projects Fund. The cost was initially included in the General Fund until adoption of the Capital Improvement Program.
2. The legal judgment is from the U.S. District Court for plaintiff's attorneys fees, \$300,000, paid in November 2011.
3. Additional funds of \$4,200 for a replacement mower for Parks Department. With trade-in of a mower purchased in 2009 that has been malfunctioning, the replacement cost is \$12,700. With \$8,500 of funds already available within its current budget, the \$4,200 of additional funds will cover the \$12,700 acquisition cost.
4. Additional funds of \$5,000 for wages and benefits in the Streets Department for needed temporary assistance to cover duties of its administrative secretary, who is currently assigned to maintain street assets in the City's asset system (Hansen).
5. \$33,846 for mold repair/remediation at Century Court that began in August 2011.

Financial Impact

The amendments, as proposed, would result in:

- a. A net increase in the fund balance of the General Fund of \$2,011,742, and
- b. No change in the fund balance of the Solid Waste Fund or Capital Projects Fund.

Options

1. Approve amendment(s) as proposed and forward to BOMA.
2. Make changes to the amendment(s) where desired and forward to BOMA.

Recommendation

Staff recommends approval of the amendments.
