1. Call to Order

Chairman Elliott called the meeting to order.

2. Roll Call/Confirm Quorum

Chairman Elliott confirmed that there was a quorum.

3. Public Comments

This portion of the agenda is for members of the public to directly address the FTA on any items not on the agenda and within the jurisdiction of the Authority. CONSENT CALENDAR

4. Minutes of July 19, 2012 Regular Meeting Minutes (ITEM #4) Chairman Elliott called to approve the minutes of the July 19, 2012 regular meeting; Mr. Hays Waldrop motioned, Ms. Nancy Fletcher-Blume seconded the motion. Motion carried unanimously.

OLD BUSINESS

5. Year-to-Date Financial Statement and Summary

(ITEM #5)

Ms. Henry presented the year to date August 31, 2012 financial statements to the Authority, noting that numbers are tracking well; 17% revenues, 18% expenses, with 17% of the year elapsed. Ms. Henry noted the increase in expenses for August was an additional payroll in the month. Transit fares are tracking well as are ridership numbers. Chairman Preston Elliott called for acceptance of the financial report. *Mr. Dale Thomas motioned, Ms. Nancy Williams seconded and the motion passed unanimously.*

Mayor Ken Moore spoke to the Authority on the expected upcoming growth for Williamson County and the City of Franklin. Tremendous new development is coming, and already started, with Columbia State Community College and Vanderbilt University Medical Center. There will be a parking challenge with this expansion, and The TMA Group and especially the Franklin Transit Authority will be integral with moving people in and around Franklin.

6. Transit Report (ITEM #6)

Ms. Henry reported the ridership. As was previously discussed the new goal is: 4,000 a month. August 2012 total: 4,641. Chairman Preston Elliott called for acceptance of the transit report. *Mr. Dale Thomas motioned, Ms. Nancy Williams seconded and the motion passed unanimously.*

7. Community Outreach and Marketing Updates
Ms. Deb Varallo spoke on the success of Dump the Pump Day and Adopt-A-Stop Celebration, noting our current special is for Seniors.

NEW BUSINESS

8. Consideration of Approval of Consolidated Human Services Transportation (BAI 9-20-12-8)

Between Franklin Transit Authority and Nashville MTA for FY 2013.

The Consolidated Human Services Transportation Plan contract between Nashville MTA and Franklin Transit Authority was presented for approval. These are regular operating funds to expand service to disabled and seniors in Franklin. Franklin Transit Authority applied for, and was selected to receive \$136,026.00 total in New Freedom Funds. Chairman Preston Elliott called for the approval of the funds. *Mr. Dale Thomas motioned, Mr. Hays Waldrop seconded and the motion passed unanimously.*

9. Contract for Consideration- State Matching Contract for FY 2013 5307 Funds (BAI 9-20-12-9)

Ms. Henry informed the Board this is the state match for 5307 operating funds. This is the 6th year Franklin Transit has received these funds. This year's amount is \$214,524.00. Chairman Preston Elliott called for the approval of the funds. *Mr. Hays Waldrop motioned, Ms. Nancy Fletcher-Blume seconded and the motion passed unanimously.*

10. Approve TDOT Matching Contract

(BAI 9-20-12-10)

Ms. Henry informed the Board this is the state match for FY 2011 5307 capital allocation. State match is \$82,939, with total federal, state, and local funds being \$829,394. Chairman Preston Elliott called for the approval of the funds. *Ms. Nancy Williams motioned, Mr. Dale Thomas seconded and the motion passed unanimously.*

OTHER BUSINESS

10. Report of Executive Director

Ms. Henry informed the Authority of one change in TMA staff, a promotion for Stanton Higgs, the new Business Development and Operations Director. Mr. Higgs will have greater responsibilities in VanStar and Transit, especially in the day to day operations. Ms. Henry also noted that Franklin Fast Passes are being sold online through The TMA Group website.


Ridership by Route for October 2012







Discover – Connect – Share! Discover the alternatives to automobile transportation. Learn how to ride public transit and how to stay safe when using alternate transportation. Complete the activity requirements and earn a patch!

Daisy: complete 4 activities – one from each category and one from any category you choose Brownie: complete 5 activities – one from each category and two from any category you choose

Junior: complete 6 activities – two from each category

Cadette, Senior and Ambassador: complete 7 activities – two from each category and one from any category you choose.

Section I: Discover Transit Basics

- 1. What are the different forms of mass transit nationally and in your community?
- 2. Learn about safety: when walking, bicycling, riding the bus, and when riding your bike around transit vehicles and when taking your bike on the bus.
- 3. Pick up or download a transit schedule from your local transit authority.
- 4. Learn about the benefits transit can have for you, your family, and your community.
- 5. Learn how walking, biking, or using mass transit helps the environment.
- 6. Find out what your city, county and state government is doing to improve alternative transportation with regard to bus improvements, bike routes, pedestrian safety, etc.

Section II: Connect

- 1. Identify at least four different road signs and other safety measures that you may find near bus stops, pedestrian crossings, and rail crossings.
- 2. Figure out how to get to one of your daily activities (attending school, after-school activities, after-school job) by using transit to get to and from those locations.
- 3. With a parent, ride a transit bus or trolley to one of your regular destinations (for example, school, the YMCA, the grocery store or your doctor's office).
- 4. With a parent, safely take your bike on a Franklin Transit vehicle.
- 5. Take a tour of the Franklin Transit Authority, the Music City Star station, or other mass-transit office.

Section III: Share!

- 1. For Daisy and Brownie: Draw a picture and write (or have an adult help you write) a few sentences about what you have learned about transportation. Which mode of transportation is your favorite? Share your drawing and ideas with your troop. For Junior, Cadette and Senior: Write a few paragraphs detailing what you learned about transportation; share it with your troop.
- 2. Get creative and organize a neighborhood event encouraging your neighbors to leave their cars at home and use alternative transportation for one day. Remember to share what you have learned about the benefits of transit!
- 3. Film or record a public service announcement for your community about pedestrian, bicycle, bus or rail safety.
- 4. Create a photo slideshow, scrapbook, or short video to share what you have learned about transportation in your community.
- 5. Distribute Franklin Transit schedules and (safety/other) materials at your school or church.
- 6. Create a poster encouraging your community to use transit. Display your poster at school, church, or a local business.
- 7. Create a "walking school bus" (see video link) or schedule a "Walk to School Day" with your school. *Hint:* You may also combine other modes of transit (Franklin Transit bus, bicycle) to get to your destination.

Item Number: 11-15-12-8 Meeting Date: 11-15-12 Item Title: Acknowledgement of Mobility Concept Plan Development – Carothers & McEwen BACKGROUND The intersection of Carothers Parkway and McEwen Drive is slated to be a central crossroads for future development growth within the City of Franklin. The growth in development and traffic need to be properly planned, implemented, and maintained for the Carothers Parkway and McEwen Drive corridors to function in an exemplary manner. In June 2012, the City of Franklin entered into a Professional Service Agreement with Kimley Horn and Associates to assist the City in the review of multiple traffic impact studies submitted for development with the Carothers Parkway Corridor. Two of the four categories identified are: Transportation Management, and Transit. The TMA Group staff on behalf of the Franklin Transit Authority have been asked to develop a Mobility Concept Plan – a plan that integrates a family of diverse technologydriven rideshare services including but not limited to transit, shuttle connections. carpooling, vanpool. All services should be accessible, safe, affordable, convenient, frequent, and connect employees, employers, citizens, and visitors to both local activity centers within the City of Franklin and important regional destinations. STAFF RECOMMENDATION Staff recommends the Franklin Transit Authority to authorize the development of a Mobility Concept Plan, subject to availability of funding, with the guidance and direction from the Authority.
