

**ORDINANCE 2012-63**

**TO BE ENTITLED: “AN ORDINANCE TO TEMPORARILY REDUCE THE SPEED LIMIT ON 5<sup>TH</sup> AVENUE NORTH/HILLSBORO ROAD (SR106) FROM FAIR STREET TO JOEL CHEEK BLVD./GRANVILLE ROAD TO TWENTY FIVE MILES PER HOUR (25 MPH) IN BOTH DIRECTIONS FOR THE DURATION OF THE HILLSBORO ROAD IMPROVEMENTS CONSTRUCTION PROJECT.”**

**WHEREAS**, 5<sup>th</sup> Avenue North/Hillsboro Road (State Route 106) is classified as a Major Arterial within the City’s Major Thoroughfare Plan; and

**WHEREAS**, the Current speed limit of 5<sup>th</sup> Avenue North and Hillsboro Road is thirty-five miles per hour (35 MPH); and

**WHEREAS**, the City of Franklin Board of Mayor and Aldermen have approved COF Contract No. 2012-0110, the Construction Contract for the Hillsboro Road Improvements Project, from SR96W to Independence Square; and

**WHEREAS**, the construction zone required to complete the Hillsboro Road Improvements Project, SR96W to Independence Square, will stretch from Fair Street to Joel Cheek Blvd./Granville Road; and

**WHEREAS**, engineering principles/judgment related to vehicular driver and construction worker safety give justification for temporarily reducing the speed limit from thirty-five miles per hour (35 MPH) to twenty-five miles per hour (25 MPH) for the duration of the Hillsboro Road Improvements Construction Project.

**NOW THEREFORE:**

**SECTION I: BE IT ORDAINED** by the Board of Mayor and Aldermen of the City of Franklin, Tennessee that the speed limit on 5<sup>th</sup> Avenue North/Hillsboro Road (SR106) from Fair Street to Joel Cheek Blvd./Granville Road be temporarily decreased to twenty-five miles per hour (25 MPH) for both directions for the duration of the Hillsboro Road Improvements Project, SR96W to Independence Square.

**SECTION II: BE IT FURTHER ORDAINED** by the Board of Mayor and Aldermen of the City of Franklin, Tennessee that the speed limit on 5<sup>th</sup> Avenue North/Hillsboro Road (SR106) from Fair Street to Joel Cheek Blvd./Granville Road be returned to thirty-five miles per hour (35 MPH) for both directions after the completion of the Hillsboro Road Improvements Project, SR96W to Independence Square.

**SECTION III: BE IT FURTHER ORDAINED** by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that the penalty for failure to obey the provisions of this Ordinance shall be as indicated in the Franklin Municipal Code and/or the Tennessee Code Annotated.

**SECTION IV: BE IT FINALLY ORDAINED** by the Board of Mayor and Aldermen of

the City of Franklin, Tennessee, that this Ordinance shall take effect from and after its passage on second and final reading, the health, safety and welfare of the citizens of Franklin requiring it.

**SUBJECT:** **Consideration of Ordinance 2012-63, An Ordinance To Temporarily Reduce The Speed Limit On 5<sup>th</sup> Avenue North/Hillsboro Road (SR106) From Fair Street To Joel Cheek Blvd./Granville Road To Twenty Five Miles Per Hour (25 MPH) In Both Directions For The Duration Of The Hillsboro Road Improvements Construction Project.**

### Purpose

The purpose of this memo is to recommend approval of Ordinance 2012-63, an Ordinance to temporarily reduce the speed limit On 5th Avenue North and Hillsboro Road from Fair Street to Joel Cheek Blvd. and Granville Road to twenty five miles per hour (25 mph) in both directions for the duration of the Hillsboro Road Improvements Project, SR-96W to Independence Square (COF Contract No. 2012-0110).

### Background

The first phase of the Hillsboro Road Improvements Project, SR-96W to Independence Square, was bid on December 3<sup>rd</sup>, and is on track to break ground in mid-January. Because of the size and scope of the roadway improvements, the project's construction limits stretch from Fair Street to Joel Cheek Blvd. For the safety of drivers and construction workers, staff recommends reducing the existing 35 MPH speed limit to 25 MPH. Previous Streetscape projects did not require a speed limit reduction, because the existing traffic patterns and signalization helped control excessive speeding. Drivers on 5<sup>th</sup> Avenue North and Hillsboro Road tend to drive the speed limit, or faster.

This Ordinance will allow the COF Police Department to enforce the lower construction speed limit throughout the duration of the construction project. The Ordinance is written with a "sunset" provision that has the speed limit reverting back to the original 35 MPH once construction activities are completed.

### Financial Impact

The COF Streets Department will fabricate and install the necessary regulatory signage.

### Recommendation

Staff recommends approval of Ordinance 2012-063 to temporarily reduce the speed limit on 5<sup>th</sup> Avenue North and Hillsboro Road.
