SUBJECT: Consideration of bid award to Thompson Machinery of La Vergne, TN in the total amount of \$136,845.92 for one (1) unused 2013 Caterpillar 924K wheeled front-end loader for the Stormwater Division of the Streets Department (Purchasing Office Procurement Solicitation No. 2013-008; \$145,000.00 budgeted in 135-89530-43120 for fiscal year 2013; Contract No. 2012-0203)

Purpose

The purpose of this procurement is to purchase a wheeled front-end bucket loader for the Stormwater Division of the Streets Department. The new equipment would replace an existing unit that is scheduled this current fiscal year to be removed from service.

Background

The City published on November 29, 2012 a Notice to Bidders in the *Williamson Herald* for a minimum of one (1) wheeled front-end loader. In addition, bid documents were sent on or about the same date directly to ten (10) potential bidders known or thought to be interested in this solicitation. Bids from three (3) vendors were publicly opened at the bid opening held on December 19, 2012. A tabulation of the bids received for this solicitation is attached.

Financial Impact

The apparent lowest, most responsive and responsible bid, from Thompson Machinery of La Vergne, TN, is in the amount of \$136,845.92 for a 2013 Caterpillar 924K wheeled front-end bucket loader. This bid was identified because it is the lowest bid that meets or exceeds the City's intention as expressed and implied by the City's specifications as well as the instructions, terms and conditions pertaining to this procurement solicitation. The Streets Department Stormwater Division budget for fiscal year 2013 allocates \$145,000 out of the Stormwater Fund for the purchase of machinery and equipment. The Thompson Machinery bid amount is \$8,154.08 (5.6%) under budget.

Options

In accordance with the bid documents, the City reserves the right to reject any and all bids.

Recommendation

Staff recommends that the City accept the apparent lowest best bid, from Thompson Machinery of La Vergne, TN, is in the amount of \$136,845.92 for a 2013 Caterpillar 924K wheeled front-end bucket loader. Purchasing Manager Brian Wilcox is of the opinion that the prepared specifications as distributed allowed for competition among multiple vendors, and that the staff recommendation appears to be made in a fair and impartial manner based upon the bids received.
