SUBJECT: Consideration of bid award to Office of Joel Tomlin, III, LLC of Franklin, TN in the total amount

of \$16,716 for tree supply, planting and related contract services for the Parks Department (Purchasing Office Procurement Solicitation No. 2013-006; \$16,866 budgeted for project with 50% to be transferred from Tree Bank Reserves and 50% to be reimbursed by State grant;

Contract No. 2012-0202)

Purpose

The purpose of this memorandum is to provide the Board of Mayor and Aldermen (BOMA) with information to consider a bid award for tree supply, planting and related contract services.

Background

The subject procurement is to purchase the supply, delivery, planting, maintenance and related contract services for a total quantity of 84 two-inch caliper trees, consisting of 15 different varieties, at seven of the City's parks. The trees would be planted according to the following distribution:

The City published on November 29, 2012 a Notice to Bidders in the *Williamson Herald* for tree supply, planting and related contract services. In addition, bid documents were sent on or about the same date directly to thirteen (13) potential bidders known or thought to be interested in this solicitation. Bids from three (3) vendors were publicly opened at the bid opening held on December 19, 2012. A tabulation of the bids received for this solicitation is attached.





Financial Impact

The apparent lowest responsive and responsible bid, from Office of Joel Tomlin, III, LLC of Franklin, TN, is in the total amount of \$18,905 for the specified estimated total quantity of 95 trees. This bid was identified because it is the lowest bid that meets or exceeds the City's intention as expressed and implied by the City's specifications as well as the instructions, terms and conditions pertaining to this procurement solicitation. The project budget is \$16,866, with 50% of the cost of the project to be transferred from Tree Bank Reserves and 50% to be reimbursed by State grant. The Joel Tomlin bid amount is \$2,039 (12%) over budget for the specified estimated total quantity of 95 trees. Therefore, staff proposes reducing the quantity of trees to be supplied, planted and maintained from 95 to 84, thus reducing the amount of the award from \$18,905 to \$16,716, a figure that is \$150 (1%) under budget. Such a reduction is consistent with the specifications of the bid which stipulated:

The exact quantities of trees to be planted pursuant to this procurement solicitation shall be determined by the City after the bids have been submitted. The City intends to plant the maximum number of trees possible, in approximately the proportions implied by the quantities estimated below, within the budget allotted for the project.

The estimated quantity for each tree variety indicated ... represents the approximate number of trees that the Parks Department anticipates planting pursuant to this procurement solicitation. These numbers are estimates only and do not represent a guaranteed minimum or maximum.

If the Board of Mayor and Aldermen approves this bid award, then the invoice(s) totaling the amount of this bid award would be allocated to the Parks Department's General Fund budget for fiscal year 2013.

Options

In accordance with the bid documents, the City reserves the right to reject any and all bids.

Recommendation

Staff recommends that the City accept the apparent lowest best bid, from Office of Joel Tomlin, III, LLC of Franklin, TN, in the total amount of \$16,716 for the total quantity of 84 trees. Purchasing Manager Brian Wilcox is of the opinion that the prepared specifications as distributed allowed for competition among multiple vendors, and that the staff recommendation appears to be made in a fair and impartial manner based upon the bids received.
