**SUBJECT:** **Water Availability Request for 3160 Del Rio Pike (Map 51, Parcel 17.10)**

**Purpose**

The purpose of this memo is to forward to the Board of Mayor and Aldermen (BOMA) a request for water availability for 3160 Del Rio Pike.

**Background**

A request for water availability for 3160 Del Rio Pike, also known as Map 51, Parcel 17.10, was submitted on January 23, 2013. This request is for 13 SFUE through a 1" domestic water meter; however, the property owner is only planning to build one single family unit. The property owner has requested service from a 1" meter based on advice from his engineer due to the service line length and change in topography. This property is not within the City Limits of Franklin but it is within the City of Franklin's Water Service Area. The City of Franklin has an existing 24" water main along Del Rio Pike that could serve this property.

Staff recommends that water availability for this parcel be granted in the amount of 13 SFUE.
