Carlisle Lane/Boyd Mill Water Line Change Order No. 1

Purpose

The purpose of this memorandum is to recommend approval to the Board of Mayor and Aldermen (BOMA) of Change Order No. 1 for the Carlisle Lane/Boyd Mill Water Line project.

Background

BOMA approved the construction contract with McMillan Construction Company, LLC, for the Carlisle Lane/Boyd Mill Water Line Project on 5/26/09 in the amount of \$179,572. This change order reflects two items: 1) additional pavement repair and 2) replacement of a 2" shared water line service with two 3/4" service lines. The shared service line was proposed initially due to the possibility of high bedrock in the area based on preliminary geologic investigations. The City's standard practice is for service lines to be installed individually. During construction, it was discovered that individual services could be installed as the bedrock was lower than expected.

Financial Impact

An increase of \$5,990 will need to be added to the construction contract with McMillan Construction Company, LLC.

Recommendation

Approval of Change Order No. 1 with McMillan Construction Company, LLC, in the amount of \$5,990 is recommended.
