Uses of the City of Franklin Zoning Ordinance

Purpose

The purpose of this memorandum is to provide the Board of Mayor and Aldermen (BOMA) with information regarding amendments to Table 3-2: Permitted Uses of the *Franklin Zoning Ordinance* to revise permitted-uses in the Light Industrial (LI) Zoning District.

Background

This Zoning Ordinance Text Amendment is requested by the Department of Building and Neighborhood Services in order to revise Table 3-2: Permitted Uses to allow Recreational Facilities (Private) and Personal Services to be a permitted-use in the Light Industrial (LI) Zoning District. Examples of facilities that are classified in these use categories are the A-Game Sportsplex (formerly Southern Ice), Ultimate Sports Basketball Academy, and Let it Shine Gymnastics, as well as Health and Fitness Centers. These businesses and others that are similar are located in the Light Industrial zoning district. These uses are compatible and consistent with the overall development pattern encouraged by the LI zone.

This text amendment was recommended unanimously by the Planning Commission at the September 24, 2009 FMPC meeting.
