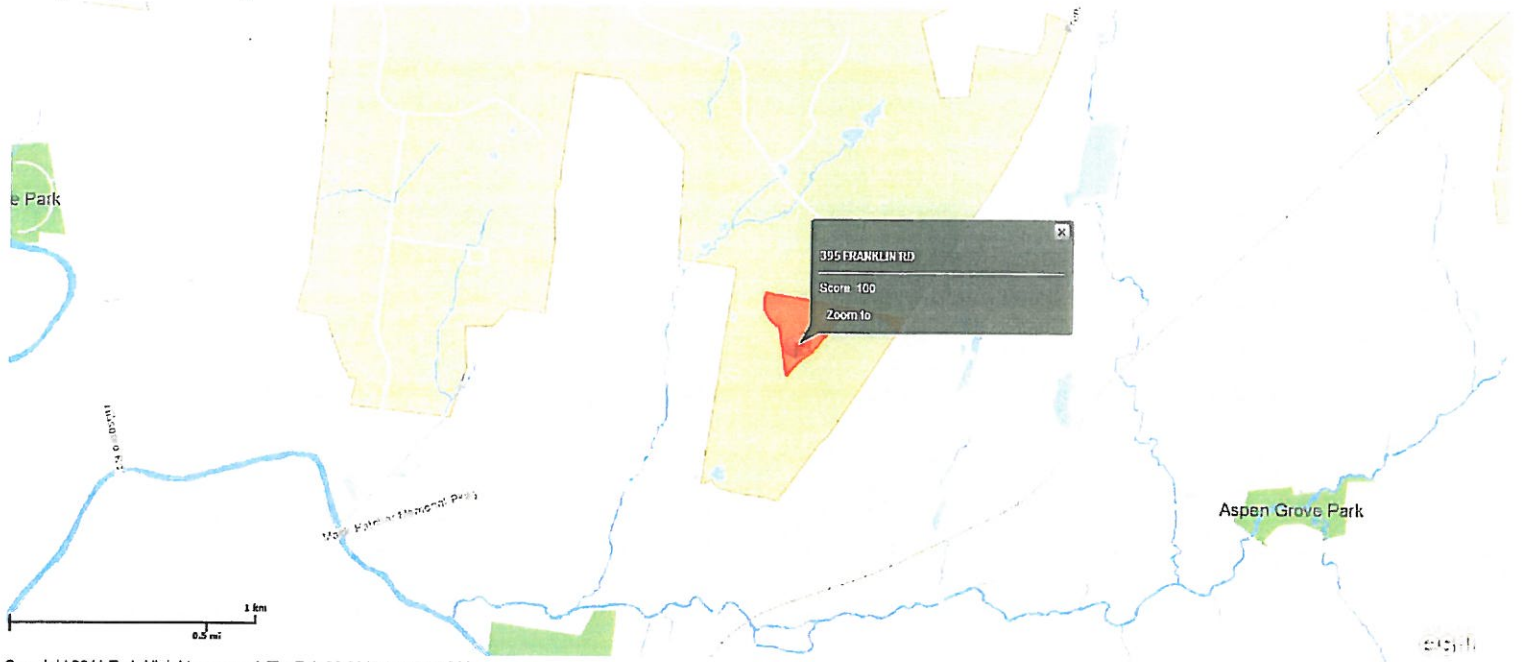

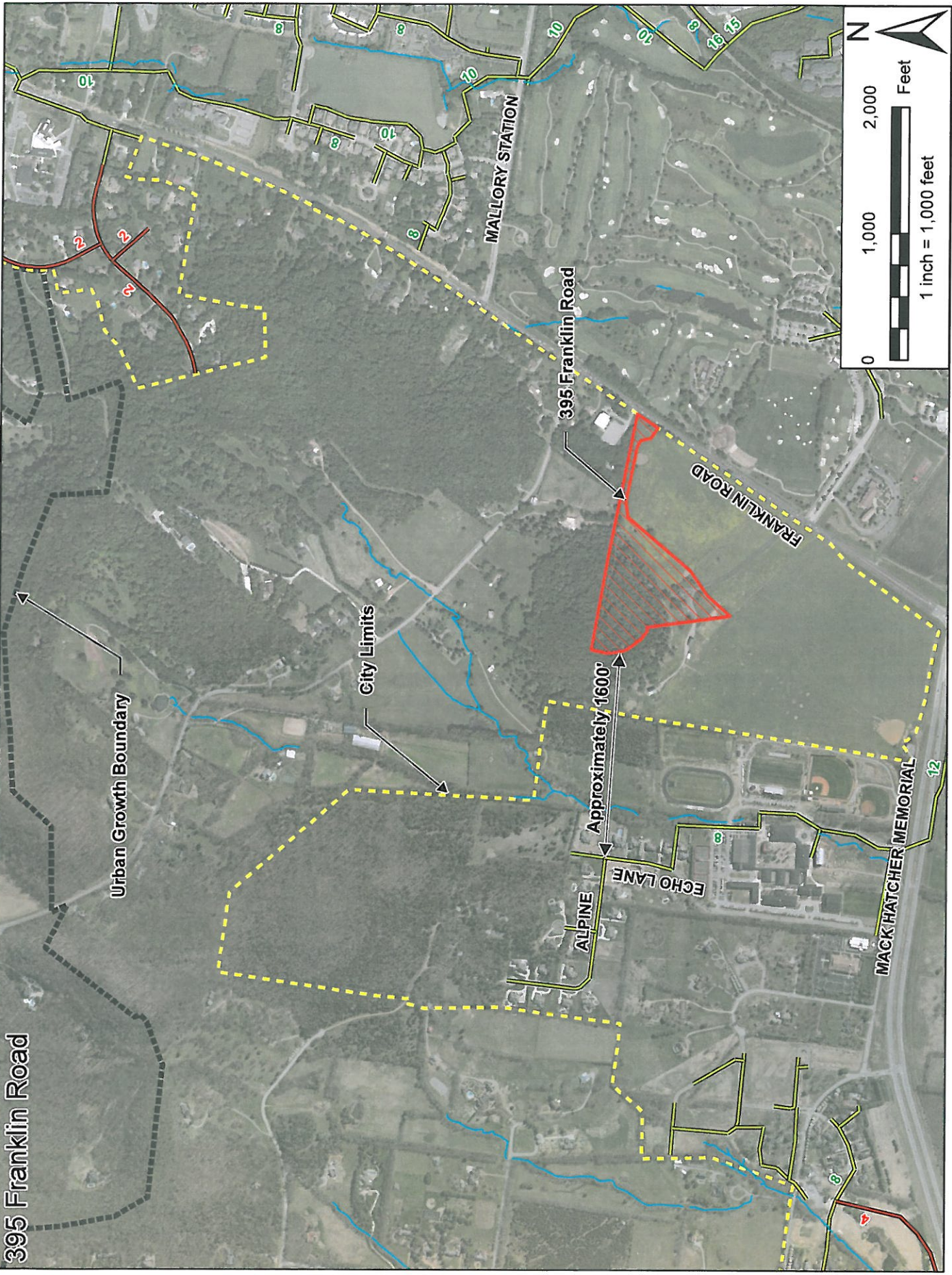

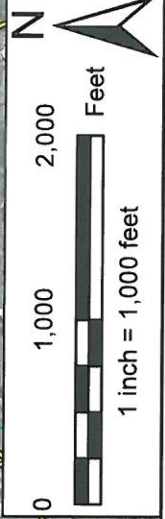

SUBJECT: Sewer Availability Request for 395 Franklin Road (Map 053 Parcel 04500).

Purpose

The purpose of this memorandum is to forward to the Board of Mayor and Aldermen (BOMA) a request for Sanitary Sewer availability for 395 Franklin Road (Williamson County Map 053 Parcel 04500).

Background

A request for Sanitary Sewer Availability (1-SFUE) for 395 Franklin Road (Map 053, Parcel 04500) was submitted on 2/28/2013. The property is located adjacent to the city limits and within the Urban Growth Boundary. The property is located in the Spencer Creek Basin and is located over 1600' from the existing sewer line in Echo Lane. There is no sanitary sewer in Franklin Road adjacent to this property. **The property owner is requesting that this availability be denied.**

It has been the Board's policy to require properties located outside of the City limits and requesting more than 1 SFUE to also require annexation. A formal annexation request has not been presented at this time.

Financial Impact

None.

Recommendation

Staff recommends denying availability per the applicant's request.
