**SUBJECT:** **Award of the Construction Contract for the West Main Street Water and Sewer Replacement Phase 2 Project (COF Contract No. 2012-0193)**

### Purpose

The purpose of this memorandum is to provide the Board of Mayor and Aldermen (BOMA) with information to consider award of the construction contract for the West Main Street Water and Sewer Replacement Phase 2 Project (COF Contract No. 2012-0193) to S & R Excavation.

### Background

The existing sewer lines from the Fair Street and 7<sup>th</sup> Avenue intersection to 5<sup>th</sup> Avenue North (Hillsboro Road) need to be rehabilitated and upsized in order to fully utilize the construction of Phase 1 of this project. The construction bids were opened on February 27, 2013, at 9:00 a.m. with S & R Excavation being the apparent low bidder. The Notice to Proceed (NTP) will be issued soon after the bid is awarded and contracts finalized.

### Financial Impact

Construction costs of \$409,045.75 to be paid out of the Water and Sewer fund. This project is classified as rate-funded capital.

### Recommendation

Staff recommends awarding the construction contract to S & R Excavation in the amount of \$409,045.75.

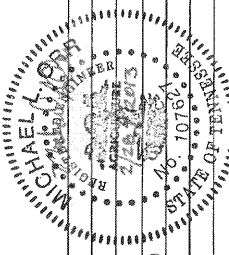
