### **Purpose**

The purpose of this memorandum is to provide the Board of Mayor and Aldermen (BOMA) with information to consider award of a construction contract for the Maplewood/Green Branch Stream Restoration Project.

#### Background

As a result of erosion and bank failures to streams, much of which can be attributed to the May 2010 flooding, City of Franklin staff inspected the main tributaries to the Harpeth River to determine the amount of damage and debris build-up the streams and drainage facilities have endured. Based on these evaluations, City Staff chose three (3) stream restoration projects to construct within the 2012-2013 fiscal year. The section of Green Branch from Sugartree Lane to the bridge for the Maplewood Amenities Center was one of these projects.

On Monday, March 4, 2013 at 10:30 a.m. bids were received in the City of Franklin Engineering Department and read aloud. Prior to opening bids, nine (9) contractors obtained official construction documents for the purpose of bidding this work. Seven (7) contractors returned their bid package. Of these seven (7) bidders, two (2) have been deemed unresponsive. The remaining bids have been reviewed for completeness as noted in the attached Bid Tabulation. A list of bidders, listed from lowest to highest bid price, can be found in the table below.

The lowest responsive bidder was Viking Products, Inc. with a bid of \$103,605.50. A Bid Tabulation Summary has been included for review.

#### **Financial Impact**

Construction costs of \$103,605.50 to be paid for out of the approved 2012-2013 Stormwater Capital Budget (89410 Drainage).

## Recommendation

Staff recommends awarding the contract to Viking Products, Inc. in the amount of \$103,605.50.
