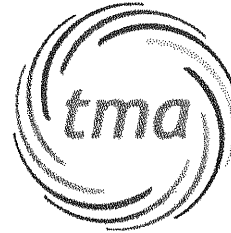

As a follow up to our meeting today, Tuesday, January 22, 2013, below you will find our request for an additional bus to be purchased.

The Franklin Transit Authority has a capital grant from Federal Transit Administration for 80% of funds needed for capital purchases. There will be a 20% match that will need to be covered by the City of Franklin, at a cost of approximately \$10,000 in additional monies from the General Fund. This grant is from 2009, and is set to expire, by the end of current fiscal year, if the funds are not used. The purchase will be for one expansion vehicle. You will find information and specs on this vehicle attached.

If these funds are not approved, we can defer the purchase of this vehicle until next fiscal year.

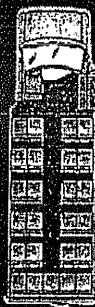
