SUBJECT: Consideration of bid award to Brenntag Mid-South, Inc. of Henderson, KY in the estimated amount of

\$44,685.13 per year for the supply and delivery upon demand of the water treatment chemical

polyaluminum chloride for a minimum of twelve (12) months for the Water Treatment Division of the Water Management Department (Purchasing Office Procurement Solicitation No. 2013-014; \$155,000 budgeted in 421-83220-52103 for all chemicals and lab supplies for fiscal year 2013; Contract No.

2013-0027)

#### Purpose

The purpose of this procurement is to price on a per unit basis the purchase upon demand for a minimum of twelve (12) months the supply and delivery to the City of Franklin Water Treatment Facility the water treatment chemical polyaluminum chloride. This chemical is routinely used by the City in the water treatment process.

### **Background**

The City published on February 21, 2013 a Notice to Bidders in the *Williamson Herald* for supply and delivery upon demand of each of the following five (5) water treatment chemicals for a minimum of twelve (12) months: (a) sodium hypochlorite (2013-010), (b) sodium permanganate (2013-011), (c) hydrofluosilicic acid (fluoride) (2013-012), (d) powder-activated carbon (hydrodarco B) (2013-013), and (e) polyaluminum chloride (PAC) (2013-014); each being bid independently. In addition, bid documents were sent on or about the same date directly to nineteen (19) potential bidders known or thought to be interested in this solicitation. Bids from four (4) vendors were publicly opened at the bid opening held on March 12, 2013. A tabulation of the bids received for this solicitation is attached.

# **Financial Impact**

The apparent lowest, most responsive and responsible bid, from Brenntag Mid-South, Inc. of Henderson, KY is in the amount of \$0.295 per pound. After taking into consideration the dosage rate that each bid product would require to meet the City's needs, the total delivered bid price for the calculated estimated quantity would be \$44,685.13 per year. This bid was identified because it is the lowest bid that meets or exceeds the City's intention as expressed and implied by the City's specifications as well as the instructions, terms and conditions pertaining to this procurement solicitation. The Water Management Department Water Treatment Division budget for fiscal year 2013 allocates \$155,000 out of the Water Fund for the purchase of chemicals and lab supplies. On a per pound basis, the Brenntag Mid-South bid amount is \$0.075 (20%) less than what the City is currently paying.

# **Options**

In accordance with the bid documents, the City reserves the right to reject any and all bids.

### Recommendation

Staff recommends that the City accept the apparent lowest best bid, from Brenntag Mid-South, Inc. of Henderson, KY in the amount of \$0.295 per pound. Purchasing Manager Brian Wilcox is of the opinion that the prepared specifications as distributed allowed for competition among multiple vendors, and that the staff recommendation appears to be made in a fair and impartial manner based upon the bids received.
