SUBJECT: Sewer Availability Request for 124 Spencer Creek Road (Map 052 Parcel 01702).

### Purpose

The purpose of this memorandum is to forward to the Board of Mayor and Aldermen (BOMA) a request for sanitary sewer availability for 124 Spencer Creek Road (Williamson County Map 052 Parcel 01702).

### Background

A request for sanitary sewer availability (1-SFUE) for 124 Spencer Creek Rd (Map 052 Parcel 01702) was submitted on 3/22/2013. The property is located adjacent to the City Limits and the Urban Growth Boundary but is outside of both. Since the property is outside of the City Limits, it is not located in one of the City's sewer basins, but it is adjacent to the Central Basin. The southeast corner of the property is about 40 feet from City sewer; however, extending sewer to the existing residence would require over 500 feet of additional sewer. **The property owner is requesting that this availability be denied.**

### Financial Impact

None.

### Recommendation

Staff recommends denying availability per the applicant's request.

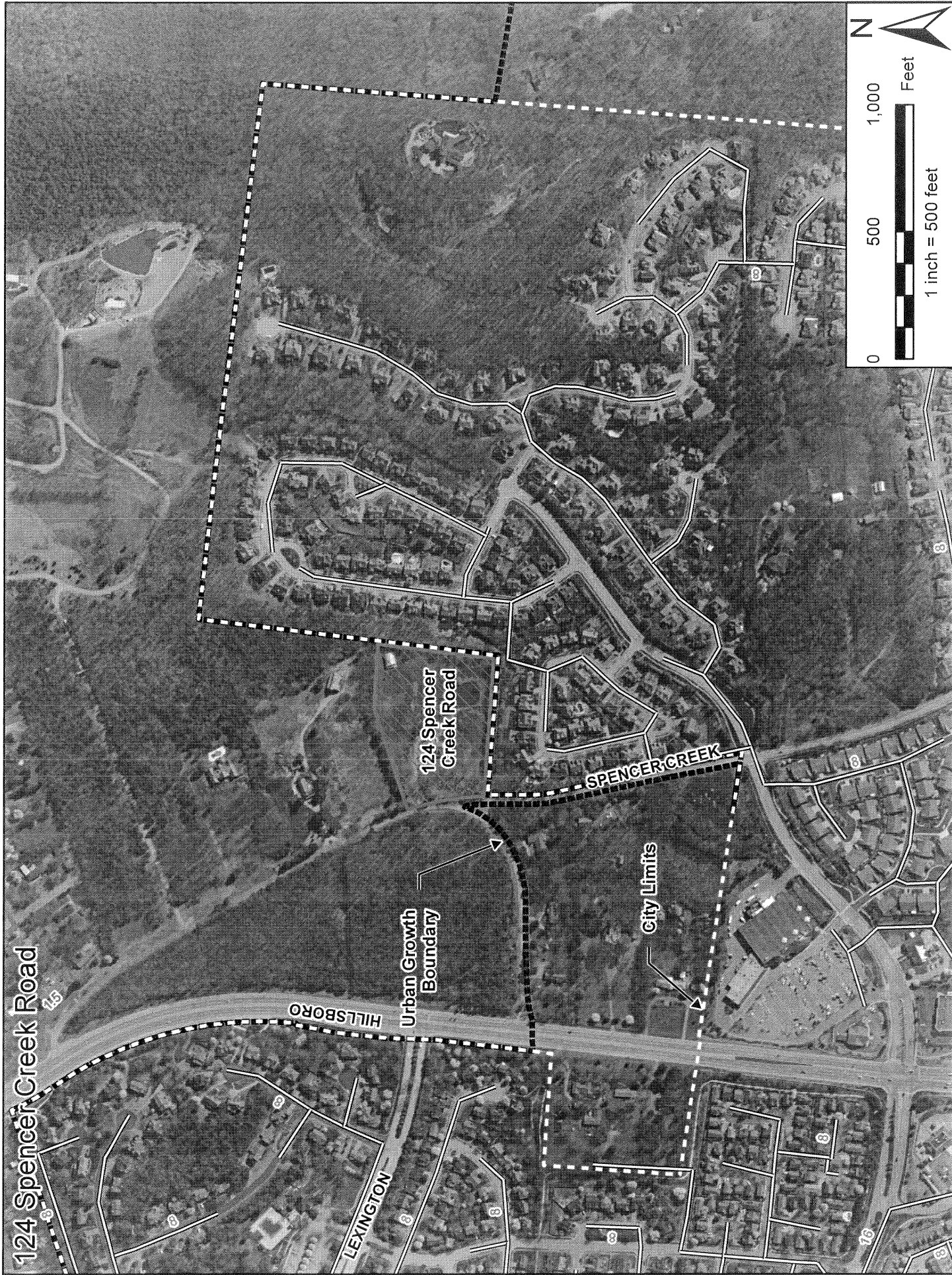
