A RESOLUTION AWARDING THE CONSTRUCTION CONTRACT (COF CONTRACT NO 2013-0048) TO MOUNTAIN STATES CONTRACTORS, LLC IN THE AMOUNT OF \$10,262,066.99 FOR THE CAROTHERS PARKWAY SOUTH PROJECT (FALCON CREEK SUBDIVISION TO THE HIGHLANDS AT LADD PARK SUBDIVISION)

WHEREAS, the Carothers Parkway South Project is listed as a Short Term Priority Project within the City of Franklin Major Thoroughfare Plan; and

WHEREAS, the construction of Carothers Parkway South generally includes a 2-lane typical section with grading to accommodate the future 4-lane typical section with curb and gutter, sidewalk (east side only), lighting, drainage and other appurtenances as required; and

WHEREAS, on May 14, 2013, sealed bids were received in the office of the City Engineer, City Hall, 109 3rd Avenue South, Franklin, Tennessee 37065 and were publicly opened and read aloud for the Carothers Parkway South Project (Falcon Creek Subdivision to Highlands at Ladd Park Subdivision) COF Contract No 2013-0048; and

WHEREAS, the Board of Mayor and Aldermen previously approved Resolution 2012-73 funding the construction of Carothers Parkway South at an estimated cost of \$12,764,722.

NOW THEREFORE, BE IT RESOLVED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that approval is granted for the bid award to Mountain States Contractors, LLC for the Carothers Parkway South Project (Falcon Creek Subdivision to the Highlands at Ladd Park Subdivision) (COF Contract No. 2013-0048) in the amount of Ten Million Two Hundred Sixty-Two Thousand Sixty-Six And Ninety-Nine/100 Dollars (\$10,262,066.99).

BE IT FURTHER RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF FRANKLIN, TENNESSEE that the City Engineer or the Director of Engineering is hereby authorized to have authority to review and approval the spending of all project funds included in the bid and award of the construction contract for the Carothers Parkway South Project (Falcon Creek Subdivision to the Highlands at Ladd Park Subdivision) (COF Contract No. 2013-0048).

Purpose

The purpose of this memorandum is to provide the BOMA the tabulated bid results for the Carothers Parkway South Extension Project and to present a recommendation for contract award.

Background

The BOMA, at their scheduled meeting on January 1, 2013, approved Resolution 2012-73, funding the construction of Carothers Parkway South, as a 2-lane facility with grading to accommodate a future 4 lanes, from the Falcon Creek Subdivision to the Highlands at Ladd Park Subdivision. This Resolution funded construction at an estimated cost of \$12,764,722.

On May 14, 2013 the City of Franklin and Sullivan Engineering, Inc. opened construction bids on the Carothers Parkway South Extension Project. Tabulated bid results (Exhibit A) are included for your review.

Financial Impact

The low bidder is Mountain States Contractors, LLC with a total construction contract price of \$10,262,066.99. This project is entirely City funded via the Capital Projects Fund.

Recommendation

Staff recommends approval of Resolution 2013-37
