SUBJECT: Sewer & Water Availability Request for 1358 Ascot Lane (Map 106B Parcel D01400)

Purpose

The purpose of this memorandum is to forward to the Board of Mayor and Aldermen (BOMA) a request for sanitary sewer and water availability for 1358 Ascot Lane (Map 106B Parcel D01400).

Background

A request for Sanitary Sewer and Water Availability (1-SFUE) for 1358 Ascot Lane (Map 106B Parcel D01400) was submitted on 4/16/2013. The property is located near City Limits and within the Urban Growth Boundary. The property is located in the Goose Creek Basin and is adjacent to City water and sewer. **The property owner is requesting that this availability be approved.**

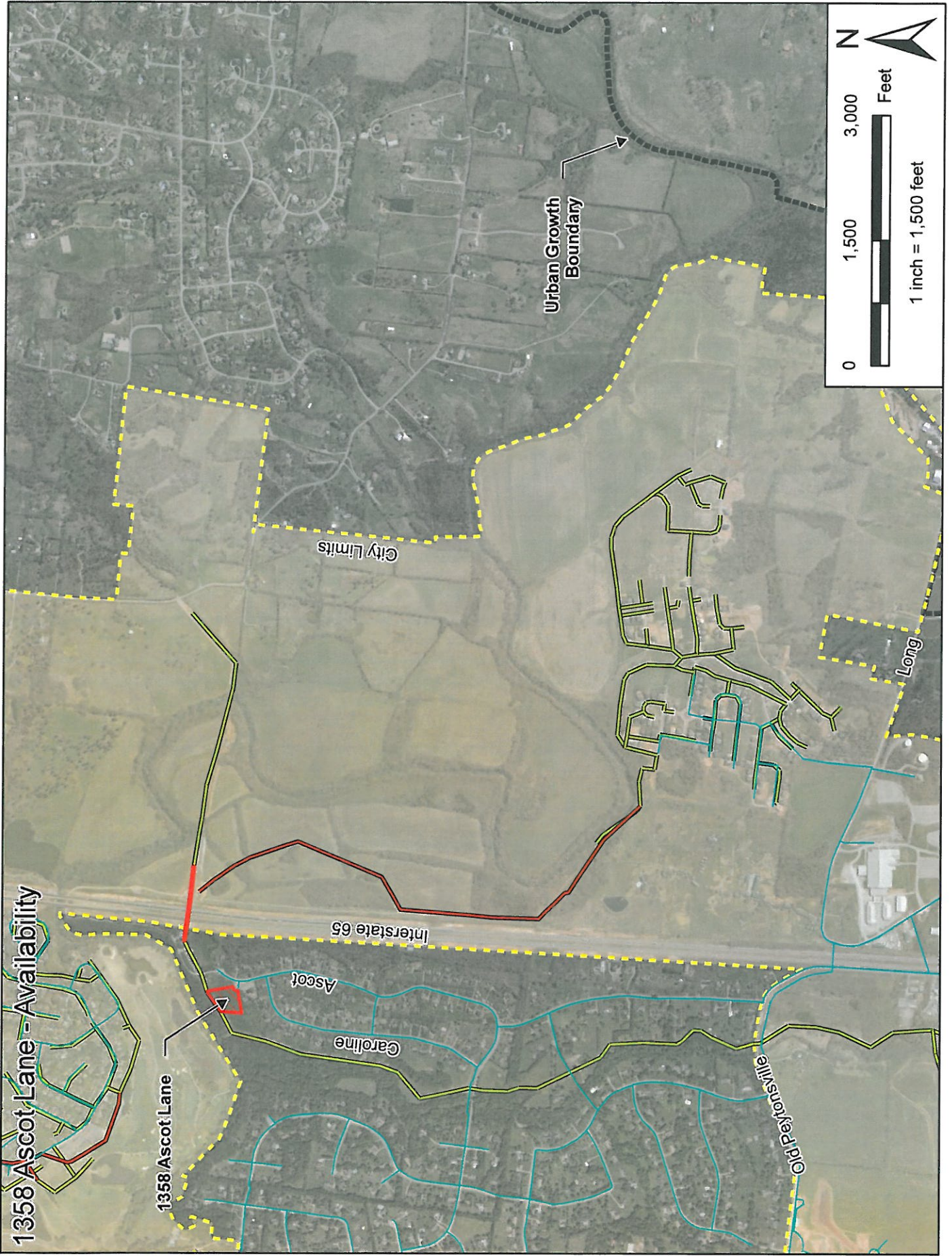
It has been the Board's policy to require properties located outside of the City Limits and requesting more than 1 SFUE to also require annexation. This property however, is for only 1 SFUE.

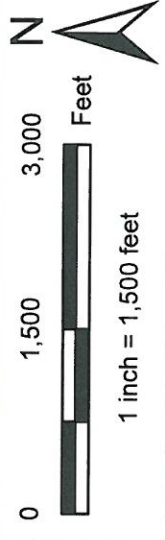
