Acres (Ralston Row PUD Subdivision) From Medium Residential District (R-2) To Residential
Variety District (RX) for the Properties Located at 121 and 123 Ralston Lane
[Second of Three Readings] Alderman Ann Petersen, FMPC Representative

With no one coming forth to speak, Mayor Moore declared the Public Hearing closed

Alderman Bransford moved to approve Ordinance 2013-36 on Second of Three Readings. Seconded by Alderman Blanton. Motion carried unanimously.

14. <u>PUBLIC HEARING:</u> Consideration of RESOLUTION 2013-46, A Resolution Approving a Development Plan for Ralston Row PUD Subdivision, Located at 121 and 123 Ralston Lane, by the City of Franklin, Tennessee

Alderman Ann Petersen, FMPC Representative

With no one coming forth to speak, Mayor Moore declared the Public Hearing closed

Alderman Petersen moved to approve Resolution 2013-46, including Modification I: Request to permit garage doors exceeding 9 feet in width on side and rear loaded garages with staff condition that MOS only apply to garages that are not street facing. Seconded by Alderman Bransford.

Alderman Martin wanted something more specific and an explanation was given.

Motion to approve Resolution 2013-46 carried unanimously.

15. <u>PUBLIC HEARING:</u> Consideration of ORDINANCE 2013-39, To Be Entitled: "An Ordinance to Amend Chapter 5, Section 5.3.5 (2) of the City of Franklin Zoning Ordinance Regulating Garage Door Width for Residential Detached Housing

[Second of Three Readings] Alderman Ann Petersen, FMPC Representative

With no one coming forth to speak, Mayor Moore declared the Public Hearing closed

Alderman Barnhill moved to approve Ordinance 2013-39 on Second of Three Readings. Seconded by Alderman Blanton.

Alderman Martin initiated discussion on the stipulation that individual street facing garage doors located on the front, side or corner façade shall be a maximum of nine feet in width and garages not street facing may have garage doors up to 18 feet in width, but in no case may a 2-car garage door be less than 16 feet in width. Concerns included not being able to get two vehicles into a garage with a 16 ft. door. Alderman Martin said she thought the design standards had been diluted allowing front loading garages.

Alderman Bransford called the Question. Seconded by Vice Mayor McLendon. Passed unanimously.

Motion to approve Ordinance 2013-39 on Second of Three Readings carried 5-3 with Aldermen Petersen, Burger and Martin voting no.
