SUBJECT: Consideration of Change Order No. 1 to the Construction Contract for the

Carothers Parkway South Extension Project (COF Contract No. 2013-0048,

Resolution 2013-37) for an INCREASE of \$560,000.00

Purpose

The purpose of this memorandum is to provide the Board of Mayor and Aldermen (BOMA) with information to consider Change Order No. 1 to the Construction Contract with Mountain States Contractors, LLC for the Carothers Parkway South Extension Project (COF Contract No. 2013-0048, Resolution 2013-37).

Background

The construction contractor for the Carothers Parkway South Extension Project was awarded by the BOMA to Mountain States Contractors LLC on June 11, 2013, in the amount of \$10,262,066.99. The full Notice to Proceed was issued for this project with an effective date of September 1, 2013. Change Order No. 1 includes the following:

- 1. Per COF Contract No. 2009-0012 and Amendment No. 1 to that contract, the City of Franklin agreed to install 1 1/2" inches of asphalt topping on Truman Road West and Alfred Ladd Road. Before this topping could be placed, approximately 425 tons of leveling asphalt was required to provide adequate roadway cross-slope for drainage.
- 2. Once grading operations began, it was discovered that the existing sub-grade materials in several areas along the project's length would require bridging with graded gravel stone to allow further placement of roadway fill. In addition to the stone, many areas require a layer of geotextile fabric to prevent migration of finer soils.
- 3. Additional storm sewer infrastructure was required to accommodate the storm water from the Highlands at Ladd Park subdivision. Also, the Carothers Parkway cross-section, within the limits of the Highlands at Ladd Park subdivision, was changed to a boulevard style section (e.g. median with one lane on each side), which required some additional storm sewer infrastructure.

There is no extension of time associated with this change order. To keep the project moving forward, approximately \$243,000 of the original \$350,000 contingency allowance has been used to pay for the items discussed above. Staff is requesting a change order in the amount of \$560,000 to replenish the contingency allowance to its original amount and to cover the additional items as discussed. Financial Impact

Change Order No. 1 to the Construction Contract (COF Contract No. 2013-0048, Resolution 2013-37) with Mountain States Contractors, LLC is for a cost INCREASE of \$560,000.00. The new contract price becomes \$10,822,066.99 (Original Contract of \$10,262,066.99 plus Change Order No. 1 of \$560,000.00.)

Recommendation

Approval of Change Order No. 1 to the construction contract (COF Contract No. 2013-0048, Resolution 2013-37) with Mountain States Contractors, LLC in the amount of \$560,000.00 is recommend.

You are directed to make the following changes in the Contract Documents:

Description:

Shortly after the start of grading operations it was determined that, the material south of the Harpeth River was not suitable as is for construction of the roadway. The geotechnical report identified that some instances of unsuitable material could be encountered therefore, what was felt to be a sufficient contingency allowance combined with the roadway undercut item would cover the expenditure. Additional funding was also used for a leveling course on Alfred Ladd and Truman Road. A field review of these two roads was done early and it was estimated that a small amount of leveling material would be required. However, once work begin it was realized that to provide the proper crown of the road and suitable riding surface much more material would be required.

The original Bid Documents stipulated the project schedule as "In accordance with Article 4 of the Agreement the Work shall be substantially completed on or before December 15, 2014, less final asphalt riding surface, permanent pavement markings, and permanent signs. The roadway lighting system shall be energized and operation 30 days prior to the general contractor requesting a review for "Substantial Completion." The project shall be ready for final completion and payment on or before April 30, 2015 in accordance with paragraph 14.07 of the General Conditions." However, for circumstances outside the control of Mt. States Contractors, the project was not able to start as anticipated because of some property acquisition issues. Therefore, a Notice to Proceed was not made effective until September 1, 2013, although Mt. States Contractors did perform some construction activities prior in an effort to expedite the project. The revised construction schedule shall be as follows "In accordance with Article 4 of the Agreement the Work shall be substantially completed on or before September 15, 2015. The project shall be ready for final completion and payment on or before November 1, 2015 in accordance with paragraph 14.07 of the General Conditions."

Reason for Change Order:

Because of the aforementioned items, the contract schedule shall be adjusted along with the original contingency allowance, which has been nearly exhausted. Replacement of the Contingency Allowance will help to avoid potential delays in construction, allowing an expeditious means to cover additional cost should any arise.
