SUBJECT: New Retail Liquor License
West Main Liquors
1326 West Main Street

Purpose

The purpose of this memorandum is to outline recommendations to the Board of Mayor and Aldermen (BOMA) for a new Retail License application received for a liquor store.

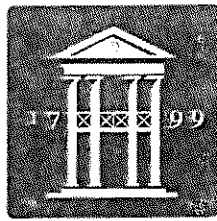
Background

Kenneth Hall has made application for a retail liquor license for a store proposed at 1326 West Main. In accordance with policy, a background records check has been performed by the Franklin Police Department and zoning approval has been received from Business and Neighborhood Services; all application requirements have been satisfied.

The City of Franklin municipal code states, "1 retail liquor license shall be allowed per every 3,000 residents". The Federal census in 2010 determined the municipal population to be 62,487. Therefore, the City of Franklin is currently allowed 20 licenses through and until the next of the next federal census (proposed for the year 2020). This application will be the 14th certificate issued out of the 20 allowed per the city's municipal code.

Recommendation

Approval of the request for a retail liquor license for 1326 West Main Street is recommended.

RETAILER'S CERTIFICATE

Pursuant to T.C.A. §57-3-208, the City of Franklin hereby certifies the following facts concerning application in the name of West Main Liquors, owned by the managing agent, Kenneth Hall, who has made application for a retailer's license to handle alcoholic beverages at 1326 West Main, Franklin, TN 37064, which is within the corporate limits of the City of Franklin, Williamson County, Tennessee:

1. The owner(s) who are to be in actual charge of the business have not been convicted of any violation of the laws against possession, sale, manufacture, or transportation of beer or other alcoholic beverages, or of any felony, or of any crime involving moral turpitude, within the past ten (10) years immediately preceding the date of application, and in the opinion of the undersigned, they will not violate any of the provisions of Tennessee Code Annotated, Title 57, Chapter 3;
2. The applicant(s) has secured a location for the business which complies with all restrictions of local law, ordinances, or resolutions, duly adopted by the local authorities as to location.
3. The applicant (by and through one or more of its owners) meets all residency requirements established by local authority under Franklin Municipal Code Section 2-108A.
4. The applicant has complied with local laws, ordinances, and resolutions duly adopted by the local authority regulating the number of retail licenses to be issued within the jurisdiction.
