SUBJECT: Sewer Availability Denial Request for 2614 McLemore Road (Map 118 Parcel 010007)

Purpose

The purpose of this memorandum is to forward to the Board of Mayor and Aldermen (BOMA) a request for sewer availability denial for 2614 McLemore Road (Map 118 Parcel 010007).

Background

A request for sewer availability denial (13-SFUE) for 2614 McLemore Road (Map 118 Parcel 010007) was submitted on October 4, 2013. The property is located outside of the City of Franklin City Limits but inside of the Urban Growth Boundary. This property is located within the City's sanitary sewer basin SW-3; however, an extension of over 2 miles of public sanitary sewer would be required to serve this site. **The property owner is requesting that this availability be denied.**

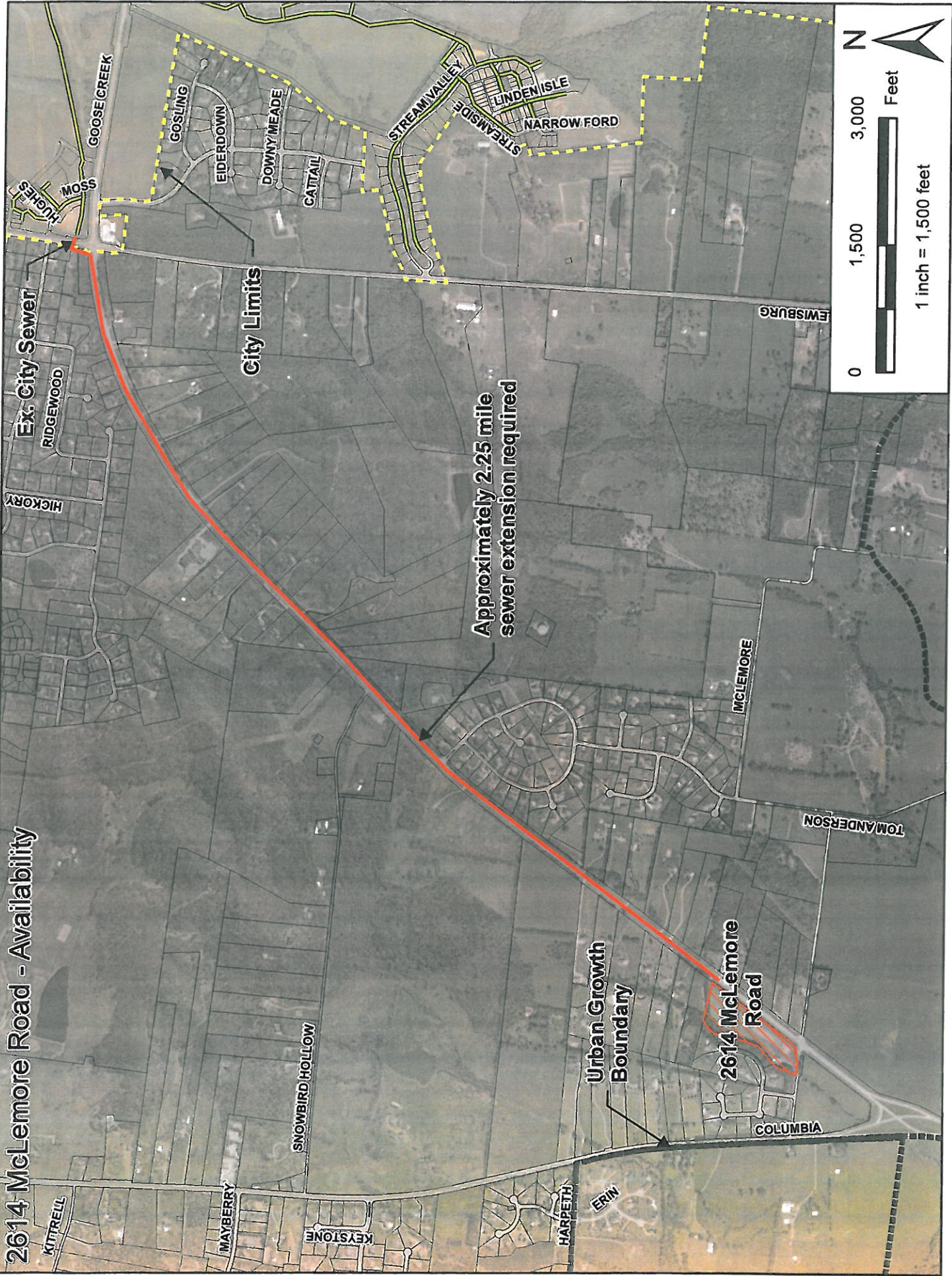
Financial Impact

None.

Recommendation

Staff recommends approving availability per our current sanitary sewer basin plan which includes extending sanitary sewer to serve Basin SW-3 which is within our Urban Growth Boundary. However, sanitary sewer is not currently available to the site, and it is understood that Thompson's Station is willing and able to serve this site. Staff understands that this property would be used as a Williamson County Rescue Squad/EMS facility site. Based on this information, if the Board chooses to deny availability, staff recommends that the denial be conditioned on an agreement between the City of Franklin, Thompson's Station, and the property owner agreeing to tie the sanitary sewer from the subject property over to the City of Franklin's sanitary sewer system once the City's system is available (in close proximity of the property as per Franklin's Municipal Code).

Drew Luna:

As regards your question about whether the Town of Thompson's Station would take issue with converting sewer service from the Town of Thompson's Station to Franklin, the answer depends on in which jurisdiction your property is ultimately located. Your property is presently in Franklin's urban growth boundary so there is presently every expectation that the subject property will someday be in Franklin.

Because the Town of Thompson's Station has agreed to provide sewer to this property outside its present jurisdiction, the town would have no issue with the sewer service being transferred to City of Franklin at such time that Franklin annexes the property. On the other hand, if by some unforeseen reason, Franklin were to decide not to annex the property. The Town of Thompson's Station would continue to provide sewer service.

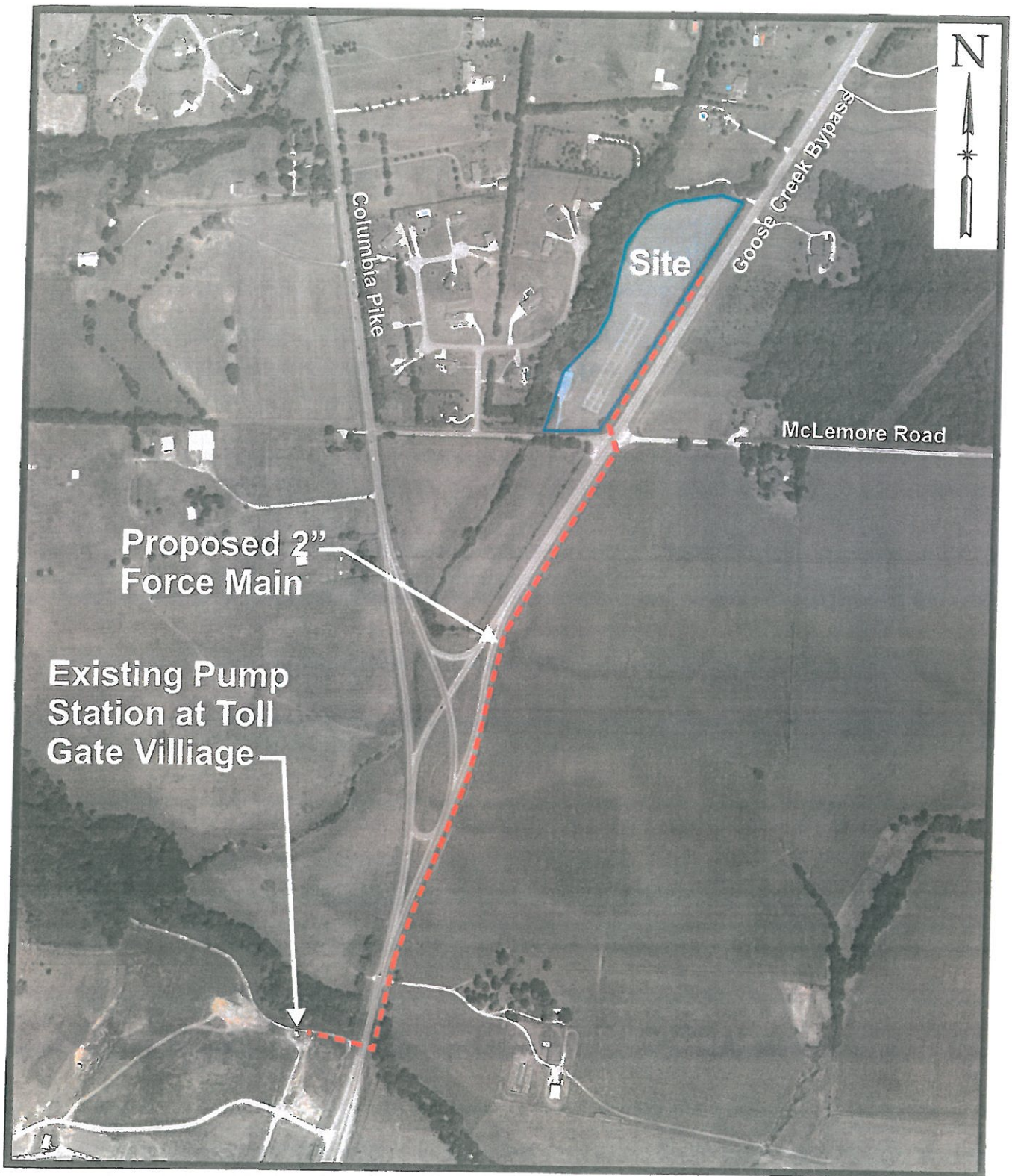
The Town of Thompson's Station is working with Drew Luna, his consultant Paul Collins and Williamson County to develop a site plan for an EMS facility off the Goose Creek by-pass near its intersection with Highway 31. Although the site is not presently within the Town of Thompson's Station boundaries, the Mayor and Board have agreed to provide extraterritorial sewer service to the facility.

The present plans propose a two inch force main within the rights of way of the Goose Creek by-pass and Highway 31. Because this sewer line is intended to sewer a public service facility, the Town has agreed that, with TDOTs consent, the contractor can work under our General Agreement. 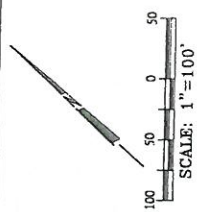

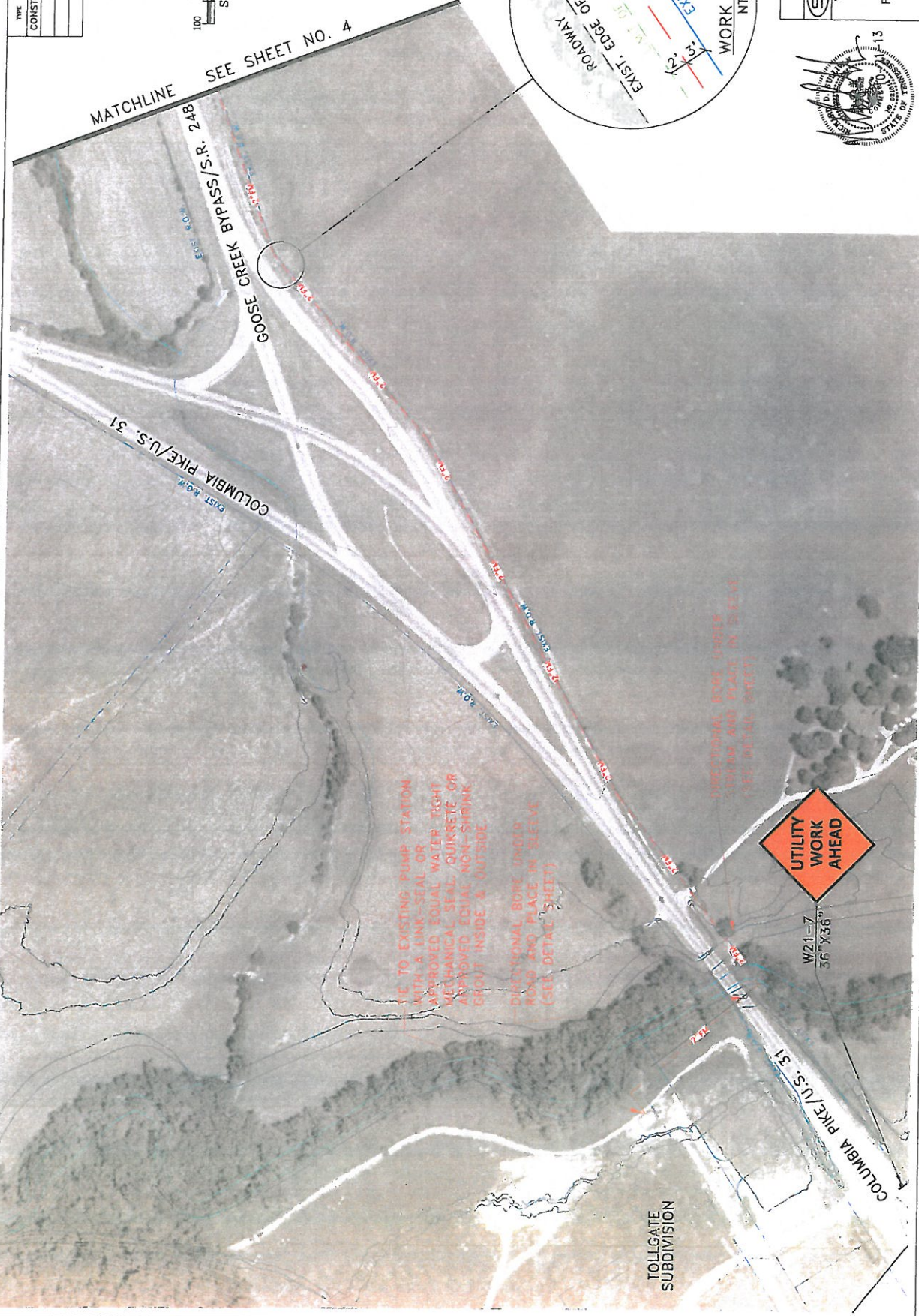
Future Home of Williamson County Emergency Management Services

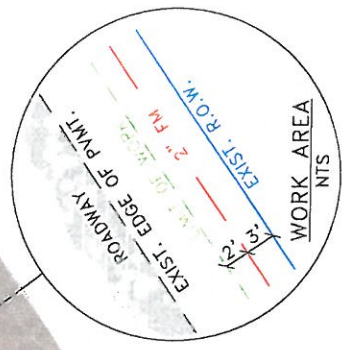

5. Minimum longitudinal cover 36-Inch
6. Minimum cover at crossing of travel way 36-Inch

- Use #67 crushed stone and tamp to proper grade.
- Restore original ground like before, or in a better condition.
