Discussion:

- Alderman Burger noted the Sanitation and Environmental Services Department is becoming self-sustaining. They no longer require a subsidy from the General Fund. Within a four-year period they took measures to cut costs and operate the department more efficiently. Becky Caldwell and her team worked hard to achieve this goal. Kudos.
- Alderman Blanton added that part of this entails the Collections Division going to a 4-day, 10 hour per day work week (from 5 days, 8 hours per day).
- Eric Stuckey commented that it is all part of the same budget and is a combination of revenue and cost control measures. As the City grows the department can maintain the same level of service without hiring additional personnel.
