1. Call to Order

Mayor Ken Moore called the January 28, 2014, meeting to order at 7:00 p.m.

2. Invocation

The invocation was given by Alderman Clyde Barnhill

3. Pledge of Allegiance

All present stood and pledged allegiance to the Flag of the United States of America

- 4. Grievances or Statements from Citizens: Citizen Comments (Open for Franklin citizens to be heard on items not included on this Agenda. As provided by law, the Board of Mayor and Aldermen shall make no decisions or consideration of action of citizen comments, except to refer the matter to the City Administrator for administrative consideration, or to schedule the matter for Board consideration at a later date. Those citizens addressing the Board of Mayor and Aldermen are requested to come to the microphone and identify themselves by name and address for the official record)
 - James D. Stucki, 221 Halberton Drive, Franklin, had a complaint about the lack of leaf removal service at his home in Fieldstone Farms. He raked 37 bags full of leaves recently. In every other place in Franklin he could have swept them to the curb and the Street Department would have come by with the vacuum truck to dispose of them. When he contacted the City he was told the policy is to not pick up leaves on private streets. Other community and federal services are provided on private streets. He said he didn't understand that as a taxpaying citizen. Leaves are picked up at homes a couple of streets over from his street. Can anything could be done about this problem?

• Dorie Bolze, HRWA, 201 Deerfield Lane, Franklin, talked about sewer and drinking water issues, five years of files reviewed that identified problems, and the HRWA's attempt to sue the City of Franklin. She mentioned working with the City on projects and obtaining grant funding for studies. She stated HRWA wants to work with the City on these issues.

6. Approval of Minutes

Vice Mayor Petersen moved to approve the January 14, 2014 Work Session and January 14, 2014 Board of Mayor and Aldermen minutes. Seconded by Alderman Barnhill. Motion carried unanimously 7-0.

Mayor Moore read a Proclamation naming Friday, February 7, 2014 as National Wear Red Day. This is to increase awareness of women and heart disease. February 7th is the 10th anniversary of wear red day.

10. Consideration of RESOLUTION 2014-10, A Resolution to Authorize the City of Franklin to Submit an Application to the Tennessee Historical Commission for the Federal Preservation Grant Program

Alderman Skinner moved to approve Resolution 2014-10. Seconded by Alderman Bransford. Motion carried unanimously 7-0.

Alderman Blanton moved to approve the Assignment of Contract with SouthernSun Financial Management. Seconded by Alderman Burger. Motion carried unanimously 7-0.

13. Consideration of Lease Extension with Banc of America to Include Kronos HR Software (COF Contract No. 2014-0022)

Alderman Barnhill moved to approve Lease Extension to include Kronos HR Software. Seconded by Alderman Bransford. Motion carried unanimously 7-0.

14. Consideration of Jordan Road Traffic Calming Request David Parker, City Engineer/CIP Executive

Alderman Burger moved to approve Jordan Road Traffic Calming Request with comment. Seconded by Alderman Bransford.

Alderman Burger said she had been working the Jordan Road residents for over a year, and there were at least two neighborhood meetings held. The speed limit is posted at 30 MPH, but many speed through at 40 MPH. A petition was presented to eight residents with all but one responding. They are in favor of installing the flashing signs that reflect the speed of the cars. Residents that could not be here tonight had asked her to speak for them.

Alderman Blanton related she had voted against these driver feedback signs at the Capital Investment Committee meeting, as they are a placebo without consequences. That stretch of Jordan Road starting near Fire Station 2 on Highway 96 is problematic and has a hill. Her concern is after a week or so when the police are no longer monitoring the area, that people will disregard the signs. These feedback signs will be installed in concrete making them permanent when it is just a temporary fix. Safety is important but she can't support a placebo. Her opinion is based on her experience of living there.

Alderman Bransford supported installing the signs as an initial attempt to resolve the problem.

Alderman Burger disagreed that the signs are permanent and cited an example where such a sign was removed. Residents there have replaced mailboxes, a dog was killed, and it is not safe for children. It will still be monitored by the police, but not continuously.

Motion to approve Jordan Road Traffic Calming Request carried 5-2 with Vice Mayor Petersen and Alderman Blanton voting no.

Alderman Burger moved to approve the appointment of Bob Martin to the Stormwater Appeals Board as a member of an organized neighborhood organization or environmental group. Seconded by Alderman Barnhill.

Alderman Skinner stated that Dorie Bolze had sent an e-mail to BOMA members and he would like it entered into the record. He said that her knowledge and expertise are invaluable and that she also works with the Williamson County Stormwater Appeals Board. He was sorry to see that she is being replaced.

Mayor's proposal to replace me on the Stormwater Appeals Board this evening at BOMA

Mayor Ken Moore called on Monday to inform me that he will be proposing to replace me on the Stormwater Appeals Board at the Board of Mayor and Aldermen meeting tonight. Please find attached a letter that I prepared for BOMA to inform its deliberations tonight. In this letter I provide some background on the expertise that I have been able to provide regarding stormwater and other related issues during HRWA's work over 14 years with the city of Franklin and other jurisdictions in the Harpeth River watershed. The mayor has offered to give me a few minutes at the Work Session tonight to briefly review this background toniaht.

Under the Ethics Chapter of the Franklin Municipal Code, HRWA's work on issues involving the city that do not pertain to stormwater regulation would not constitute any ethics issue that would affect my serving on the Stormwater Appeals Board. Based on our conversation, concerns over my service on the city's Stormwater Appeals Board over the past 4 years is not the issue in proposing to replace me on stormwater appeals board.

It is my understanding from our conversation that the proposal to replace me has been spurred by HRWA's recent 60-day notice of intent to sue the city of Franklin and the two other small sewer plants that discharge into the Harpeth River. This "notice of intent" is based on HRWA's review of state files for the past five years. For over 12 years HRWA has worked with the city and provided expert engineering and economic analysis on sewer and drinking water options and issues that affect the river's water quality. HRWA has provided signficant information on options and approaches to restore the Harpeth's water quality to state standards, all of which was provided most recently in our comments on the various draft state sewer permits. These documents have been circulated widely to city staff, BOMA, city consultants and the many other entities involved, and HRWA experts have presented aspects of our work to BOMA over the years. Our analyses, concerns, and recommendations for solutions are not new.

We are very interested in working with the city and the other two sewage treatment facilities to find resolutions that can avoid litigation. HRWA is ready and willing to meet with city officials and discuss resolutions to the problems identified in the 60-day notice whenever we are contacted by the city to set that

HRWA's goal is for the Harpeth River to meet state water quality standards that have been established to protect public health and wildlife. Regardless of the outcome of tonight's vote on my continuing service on the city's Stormwater Appeals Aboard, HRWA looks forward to continuing to work with the various city departments and leadership on stormwater management and the many other efforts we are engaged in with the city.
