

SUBJECT: Franklin High School Homecoming Parade

Purpose

The purpose of this memo is to outline recommendations for the Franklin High School Homecoming Parade.

Background

Franklin High School has requested street closures for their annual Homecoming Parade scheduled September 26th. The parade will stage along West Main Street from Five Points to (approximately) 11th Avenue. The parade begins at 10:30 a.m. The route concludes at 2nd Avenue and Church Street in the Church Street Parking lot. Estimated attendance is 1600 - 1700.

Recommendation

The following recommendations/conditions are made if the event is approved:

- Applicant will provide a Good Neighbor letter which will be distributed to affected neighborhoods.
- Risk Management:
 - o Certificate of insurance naming the City as additional insured has been received.
- Police Department:
 - Organizers will hire eleven (11) off-duty Franklin Police Officers to provide street closures and security during the event.
