SUBJECT: Sewer Availability Request for 4115 Clovercroft Road (Map 80 Parcel 31.02)

### **Purpose**

The purpose of this memorandum is to forward to the Board of Mayor and Aldermen (BOMA) a request for sewer availability for 4115 Clovercroft Road (Map 80 Parcel 31.02).

### **Background**

A request for sewer availability (1-SFUE) for 4115 Clovercroft Road (Map 80 Parcel 31.02) was submitted on July 28, 2014. The property is located within the Urban Growth Boundary and is adjacent to the City of Franklin City Limits. This property is located within the Watson Branch Basin and is within 200 feet from existing or future City sewer. **The property owner is requesting that this availability be approved.**

It has been the Board's policy to require properties located outside of the City Limits and requesting more than 1 SFUE to also require annexation. This request however, is for only 1 SFUE.

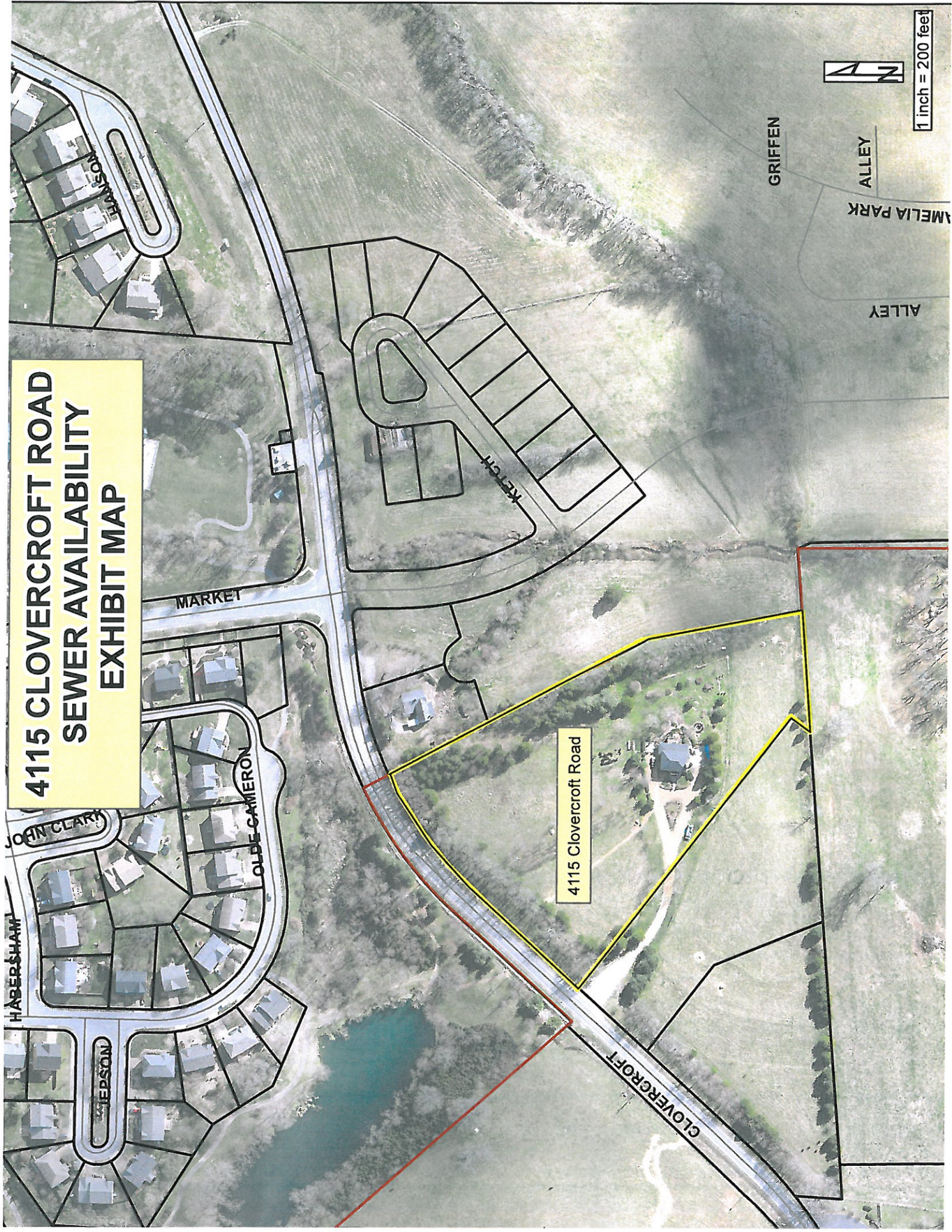
### **Financial Impact**
