1. Call to Order

Chairman Preston Elliott called the meeting to order.

2. Roll Call/Confirm Quorum Chairman Preston Elliott confirmed that there was a quorum.

3. Public Comment

4. Minutes March 17, 2011 Regular Meeting

Dale Thomas motioned to approve the minutes of the March 17, 2011 regular meeting. Nancy Fletcher Blume seconded the motion. Motion carried unanimously.

5. Year – to – Date Financial Statement

Ms. Henry shared that the FY 2011-12 Transit Budget was moving through BOMA's budgetary process. She thanked Erin and Kristen – COF staff for their assistance. *Nancy Williams motioned, Dale Thomas seconded and the motion passed unanimously.*

7. Route Match Update

Ms. Henry noted that a major software update took place 2 weeks ago; encouraged members to note display monitor. Authority requested that we move forward with placement of other display monitors.

8. Triennial Review Update

Ms. Henry shared copies of the Official Triennial Review release letter from Federal Transit Administration.

9. Historic Transit Route

Ms. Henry stated that at the last meeting preliminary discussion was had about revisiting the Historic Route, given that the 150th anniversary of the Battle of Franklin is approaching;

service would be structured differently; ticket package a possibility. Mark Shore, E.D. of WCCVB guest. Mr. Shore stated that there is a new joint house ticket; suggested making it simple for folks to use; need to get hoteliers to buy in to it; suggested working with Battle of Franklin Trust – marketing grants available with WCCVB. The Authority requested at the July meeting, staff present a well developed plan of implementation.
