It's that time of year again for citizen government academies! Both the Police

Department and the City of Franklin are taking applications. The Police Academy classes meet for eight consecutive Thursdays from 6-9:00 pm. There are a few slots remaining in the cohort that begins September 6. Once it fills up, applicants will be placed on a waiting list and invited to attend a future offering. The Department hosts two a year. Click for more info and to apply The City of Franklin is accepting applications to the Academy, which provides insight into local government. The next session will begin in Fall 2018. Classes are held on Thursdays as well, beginning at 6:00 PM, and run for eight (8) consecutive weeks. A Saturday tour of City facilities is also included. Participants will learn about the wide variety of services provided by the City and about key areas such as planning, finance, public works, and public safety. Participants will also have the opportunity to tour key facilities, talk with City officials, and gain a new perspective on the inner-workings of their local government. Applications are available online. They can also be downloaded here [PDF]. Applications are due by August 3, 2018.

The Finance Department will host a training session on updates to City policies on Wednesday, August 1st, from 9 a.m. – 11 a.m. in the City Hall Training Room. These updates were approved by BOMA on June 26. Sign-up information will be sent to each department soon. The updates to be covered are the travel policy, payroll policy, disbursements policy, and internal controls. The training will also include a discussion of project numbers for project tracking and reporting. The updated polices are available on the City's website under *Government-Finance and Administration-Financial Policies*.
