SUBJECT: Consideration of bid award to Bob Ladd & Associates, Inc. (d/b/a "Ladd's") of Memphis, TN in

the amount of \$12,569.86 for one (1) new self-propelled athletic field drag (Purchasing Office Procurement Solicitation No. 2010-037; \$12,000 Budgeted In 110-89530-44700 for fiscal year

2010)

Purpose

The purpose of this procurement is to purchase a new self-propelled athletic field drag. This equipment would be used by the Parks Department for grooming the skinned areas of baseball and softball fields. The new equipment would replace a similar piece of equipment that is scheduled this current fiscal year to be removed from service and is not worth maintaining.

Background

The Parks Department budget for fiscal year 2010 allocates \$12,000 out of the General Fund for the purchase of a new self-propelled athletic field drag.

Financial Impact

The City published on April 15, 2010 a Notice to Bidders in the *Williamson Herald* for a minimum of one (1) new self-propelled athletic field drag. In addition, bid documents were sent on or about the same date directly to four (4) potential bidders known or thought to be interested in this solicitation. Bids from four (4) vendors were publicly opened at the bid opening held on April 29, 2010. A tabulation of the bids received for this solicitation is attached. The apparent lowest, most responsive and responsible bid, from Bob Ladd & Associates, Inc. (d/b/a "Ladd's") of Memphis, TN, is in the amount of \$12,569.86 for the specified equipment. This bid was identified because it is the lowest bid that meets or exceeds the City's intention as expressed and implied by the City's specifications as well as the instructions, terms and conditions pertaining to this procurement solicitation. The apparent lowest best bid amount is \$569.86 (4.7%) over budget. Parks Director Lisa Clayton advises that this purchase may be accommodated within the department's overall budget for fiscal year 2010.

Options

In accordance with the bid documents, the City reserves the right to reject any and all bids.

Recommendation

Staff recommends that the City accept the apparent lowest best bid, from Bob Ladd & Associates, Inc. (d/b/a "Ladd's") of Memphis, TN, in the amount of \$12,569.86 for the specified equipment. Purchasing Manager Brian Wilcox is of the opinion that the prepared specifications as distributed allowed for competition among multiple vendors, and that the staff recommendation appears to be made in a fair and impartial manner based upon the bids received.
