To Whom It May Concern:

My name is **David Pack**, and I oversee operations at The Factory at Franklin. I am writing in reference to **Kevin Lindsey** and the incredible assistance he provided us in a tense and possibly dangerous situation on our property.

When the Pilgrimage Festival evacuated the farm due to inclement weather, thousands of people, possibly 8,000-12,000, flooded into our building in sudden fashion. Although we knew of the risk of this occurrence and were warned as it began, we were wholly unprepared for the volume of people and the loss of control we incurred. . . . Kevin and his team showed up with a great sense of understanding, confidence, and leadership that quickly changed the dynamic of the crisis. Their strategic method of communication and crowd control stabilized the pervasive and potentially volatile uncertainty of the mob. They were great. A handful of policemen showed up soon afterward, and their presence was a difference maker, too, but it was the rapid deployment of Kevin and his team that saved the day. We could not be more thankful, or impressed, by what we witnessed in their efforts on our behalf and on behalf of the public that evening. Franklin as a municipality is fortunate to have Kevin amongst its leadership, and so are we.—David Pack-The Factory
