


Friday, August 3, 2018

Andrew Southern and the GIS team created a smoke alarm survey for the Franklin Fire department via the ARC GIS platform. Last Saturday morning, July 28, Andrew personally trained the firefighters how to use the survey, before they utilized it for the first time in the field. Following the training with Andrew, Captain Tyler Crews and firefighters from Station 2 visited 55 homes and installed 29 smoke alarms in the Hill Estates subdivision. The survey, which replaces a three-page paper form/waiver with an electronic form that firefighters can access easily on their MDTs or cell phones, allowed them to easily track their results (see example below). Great job, Andrew and team!
