## FRANKLIN SUSTAINABILITY COMMISSION

# April 5, 2019

The Franklin Sustainability Commission held a regular meeting on Friday, April 5, 2019, at 8:00 a.m., in the Community Development Conference Room.

**Members Present**: Chair Dana Kose, Todd Palmer, Micah Wood, Nancy Whittemore, and Patrick Baggett

#### **Welcome/Introductions**

**Chair Kose** called the meeting to order at 8:00 a.m. Introductions were made.

#### **Approval of Meeting Minutes**

**Ms. Whittemore** moved, seconded by **Mr. Wood,** to approve the minutes from March 1, 2019. The motion carried (5-0).

**Mr. Baggett** asked if there was any discussion to create an ordinance for scooter regulations. **Mr. Orr** stated that two people were looking into starting the process.

#### **Announcements**

### Marshall County Recycling Hub Tour

**Mr. Orr stated** that the tour will take place on May 3<sup>rd</sup>. There is an Outlook invite for the Commissioners. He suggested everyone wear closed-toe shoes.

#### TDEC Food Smart Program

**Mr. Wood** stated that this program is to "Promote using food wisely". The program promotes providing food waste for composting. The program is looking for partners from local governments and businesses to participate in composting. **Ms. Kose** stated that there is a vendor at the Franklin

Farmer's Market (at the Factory) who will take food waste for composting. **Mr. Wood** stated that the TDEC group is asking people to take a pledge. **Ms. Whittemore** will check into a program in Nashville that works with local restaurants. She stated they use a visual presentation at events to show the benefits of composting. She stated that their Fleet Department was participating. **Ms. Kose** stated that they should be invited to a future meeting.

#### Gov's Environmental Awards LEED for Cities

**Mr. Orr** stated that they are working on the application and it will be for the Sustainable Performance category.

# **Local and Regional Transit Options**

Mr. Steve Bland is the CEO for the Regional Transportation Authority (RTA). The RTA began in 1988. Their legislative area is a ten-county area with Davidson County at the center. They work with nine of the counties. **Ms. Dannenfelser** is the Governor's appointee for Williamson County for the 39-member board. About ten years ago, RTA contracted with the Nashville Metro Transit Authority to manage their day to day services. Metro Nashville Transit Authority and RTA are both rebranding to "WEGO". They manage ten commuter routes to and from Downtown Nashville to surrounding counties. They also manage the Music City Star railway. One of the major challenges for the success of the program is directly related to the quality of the Park and Ride locations. The location needs to be convenient, have good lighting, and be secure. The big challenge for the Franklin/Cool Springs area is to find a permanent Park and Ride area. There is an express service from Franklin that meets at the Ag/Expo Center. This is not convenient for people in Cool Springs because they have to drive south to go north. Each time the park and ride location moves, they lose riders. For the strategic plan, they are working with commuters to identify areas of concern. They are working with TDOT to enable the RTA buses to use the interstate shoulder when traffic is at a slow speed. This tactic has been successful and found to be safe in several states. There is a study looking at alternatives to improve mass transit from Maury County to Downtown Nashville. Most bus service is contracted through Grayline Bus Service. The RTA is looking to establish a brand identity. The long-term goal is to have seamless commuting to connect the commuter choices, even though it will involve separate organizations. They are also looking to create a smart card for riders. They are looking to use GPS for trip planning to work with Uber, Lyft, scooters, etc. to connect riders to park and ride locations. The Easy Ride program works with employers help underwrite the cost of using the commuter service. For example, an employer may pay for the parking cost while the employee pays for the parking pass. Ms. Whittemore stated that a major benefit would be if employers would enable employees to start their work day while on the bus. The RTA buses have wireless internet service

available. There are some electric buses in Nashville. There is a challenge to use these for longer commuter routes. **Mr. Bland** stated that there would be three-wheel scooters coming soon to the area. The long-term goal is to connect and create a network for the regional activity centers such as RTA, TMA, Franklin Transit, Uber, Lyft and scooters. Finally, RTA is looking to expand the Spring Hill service to Columbia.

# **Ms. Debbie Henry** discussed the following about TMA:

- Established in 1988 as a public-private partnership of business, governmental, and community leaders
- First TMA established in the Southeast 35th in the nation
- Governed by 25-member Board of Directors comprised of City and County Mayors, CEOs, Business Owners, and Community Leaders.
   Ms. Dannenfelser is on the Board.
- Work closely with local and regional municipalities, GNRC/MPO, TDOT, ACT, Federal Transportation Administration
- TMA is a designated National Best Workplaces for Commuters
- Serve Employers, Employees, Developers, Elected Officials, Users, Citizens, Local Governments, Federal Government, and State Governments
- Serve the Middle Tennessee area approximately 15 counties
- TMA supports a regional transportation system that provides a variety of sustainable, accessible, affordable, reliable, and interconnect transportation solutions that are both healthy for the environment and for people.
