

**AGREEMENT BETWEEN THE FRANKLIN CHAPTER #14, UNITED DAUGHTERS OF  
THE CONFEDERACY AND THE CITY OF FRANKLIN, TENNESSEE FOR THE  
MAINTENANCE OF THE FRANKLIN SQUARE MONUMENT**

THIS AGREEMENT, (hereinafter "Agreement"), made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2010 by and between THE CITY OF FRANKLIN, TENNESSEE (hereinafter CITY) and FRANKLIN CHAPTER #14, UNITED DAUGHTERS OF THE CONFEDERACY (hereinafter "UDC").

**WITNESSETH:**

**WHEREAS**, the Franklin Square Monument (hereinafter "MONUMENT") was erected in 1899 after the UDC coordinated donations from the citizens of Williamson County;

**WHEREAS**, since the MONUMENT was installed, it has remained one of the lasting symbols of Franklin, Tennessee;

**WHEREAS**, the MONUMENT is an important community landmark;

**WHEREAS**, the CITY understands the importance of ensuring the condition of the MONUMENT for its historic preservation;

**WHEREAS**, the MONUMENT has historically been overseen by the UDC; and

**WHEREAS**, it is the common desire of the CITY and the UDC that the MONUMENT have regular maintenance and periodic assessments of its condition.

**NOW THEREFORE BE IT RESOLVED THAT THE CITY AND THE UDC AGREE AS FOLLOWS:**

1. The foregoing recitals are incorporated herein as it set forth at length.
2. The UDC agrees to continue its traditional role of observing the MONUMENT.
3. The UDC shall advise the CITY if there are concerns about the condition of the MONUMENT or if it appears that maintenance is needed.
4. The CITY shall have the sole discretion as to the MONUMENT'S maintenance and care after reviewing the advice from UDC. However, the CITY is not bound to act on the advice given by the UDC.
5. The CITY and the UDC agree that it is their respective desire to protect the MONUMENT for posterity. Therefore, the CITY and the UDC agree to pledge their efforts to maintain the MONUMENT in good condition at its present location in the Franklin Square.
