## **Project Description:**

This is a proposed revision to Envision Franklin. The applicant is requesting an amendment to the Envision Franklin Land Use Policy on this site from Large Lot Residential to Single Family.

## Why are you receiving this letter?

The proposed project is within 500' of your property.

### What is the purpose of the meeting?

The purpose of the meeting is to make citizens aware of a potential new development within your immediate vicinity and allow you to engage with the applicant early in the review process. The meeting is meant to be informative and provide an opportunity to ask questions directly to the developers about the project. If the project continues with a formal application to the city, it will go through a Public Hearing process. Please be aware that Public Hearings do **not** involve a question and answer session.

### Will the project be voted on at this meeting?

The project, should the applicant continue with a formal application, will be reviewed by the Franklin Municipal Planning Commission (FMPC) on Thursday, June 25, 2020. The FMPC meeting will be publicly noticed and will include time for citizens to speak to the project at formal Public Hearing sessions.
