

Good morning, team,

The City of Franklin was named the 8th Best Places to Live by Money Magazine. This year, Money looked at towns and cities with a population of at least 25,000 and ranked the Best Places to Live putting the greatest emphasis on economic factors, like employment opportunities, as well as supply and demand for homes, cost of living, quality of schools, racial and economic diversity, and health and safety. Money magazine reported Franklin as a strong contender for the past few years, twice ranking in the top 10. One of the top reasons mentioned was the Pilgrimage Festival. The magazine also said Franklin has seen a 44 percent job growth in the last 10 years, matched by a 33 percent increase in population. The median household income of \$110,000 and the median price for a family home is \$495,000. Another big reason was the quality of our schools. Kev Changes:

Up 835 more positive cases day over day in the State of Tennessee (187,544 total positive cases – most total positive cases since the pandemic began)

Down 704 fewer active cases day over day in the State of Tennessee (14,081 total active cases)

Up 26 more positive cases day over day in Williamson County (5,165 total positive

cases - most total positive cases since the pandemic began)


Down 30 fewer active cases day over day in Williamson County (316 total active cases)

Level Williamson County share of total positive cases within Tennessee at 2.8%

Level Percent Positive / Total Tested at **7.5%**

Level Williamson County **sixth** highest # of positive cases in Tennessee

Level No additional deaths in Williamson County (36 - eleventh highest in state)
