VACATION BUY BACK PROGRAM

By now you should have received a letter from Human Resources regarding the employee buyback program. Due to the on-going pandemic, it is proposed that the **City offer a one-time option for City team members to "sell back" one work week** (40 hours for regular employees and 54 hours for Fire shift personnel) of their vacation time. To qualify, employees must have at least 80 hours (108 hours for Fire shift personnel) of vacation accruals as of November 1, 2021. Employees will elect if they want to sell back 40 hours (54 hours for Fire shift personnel) of their vacation time via a form submitted to Human Resources. If employees elect to sell their time, it will be paid in December 2021. Employees cannot choose to sell back less than 40 hours (54 hours for Fire shift personnel). Under no circumstances would an employee be able to create a negative vacation balance by participating in this one-time program. A final decision by eligible employees to "sell back" a week of vacation must be made by November 1, 2021. This will allow for the processing of the additional payment through the payroll system. **Another memo will be sent in October for employees to elect if they want to sell back time for a decision to be made no later than November 1**st.


Victoria Harrington, Information Systems Analyst I

Up 134 More positive cases day over day in Williamson County (35,681 total positive cases)


Down 88 Fewer active cases day over day in Williamson County (2,020 total active cases)
