REMINDER: New City Hall Preliminary Master Plan has been released! The Master Plan will serve as the road map for the future design and development of the entire City Hall Site. The vision of the Master Plan is the result of an extensive process of research and information gathering, case study investigation, and public outreach that began in Fall of 2020. The existing one-story repurposed mall building will be demolished and replaced with a state-of-the-art City Hall facility on the Southeast quadrant of Public Square. The facility will be designed with the goal of providing flexibility for the future growth and the evolving needs of the city. The vision of the building and site is one that responds to the rich historic fabric of downtown Franklin in a responsible and sensitive way while providing a modern, yet timeless City Hall building to facilitate the continuation of the high standard of services and care for the citizen of Franklin.

Kev Changes:

Up 2,449 More positive cases day over day in the State of Tennessee (1,246,815 total positive cases)

Up 45 More positive cases day over day in Williamson County (38,691 total positive cases)


Down 71 Fewer active cases day over day in Williamson County (811 total active cases)
