Up 9,838 More positive cases day over day in the State of Tennessee (1,866,676 total positive cases)

Up 1,359 More active cases day over day in the State of Tennessee (183,881 total active cases)

Up 242 More positive cases day over day in Williamson County (58,019 total positive cases)

Down 66 Less active cases day over day in Williamson County (5,583 total active cases) – This is the first drop in active cases we have seen in approximately two months!

Level Williamson County share of total positive cases within Tennessee at **3.2**

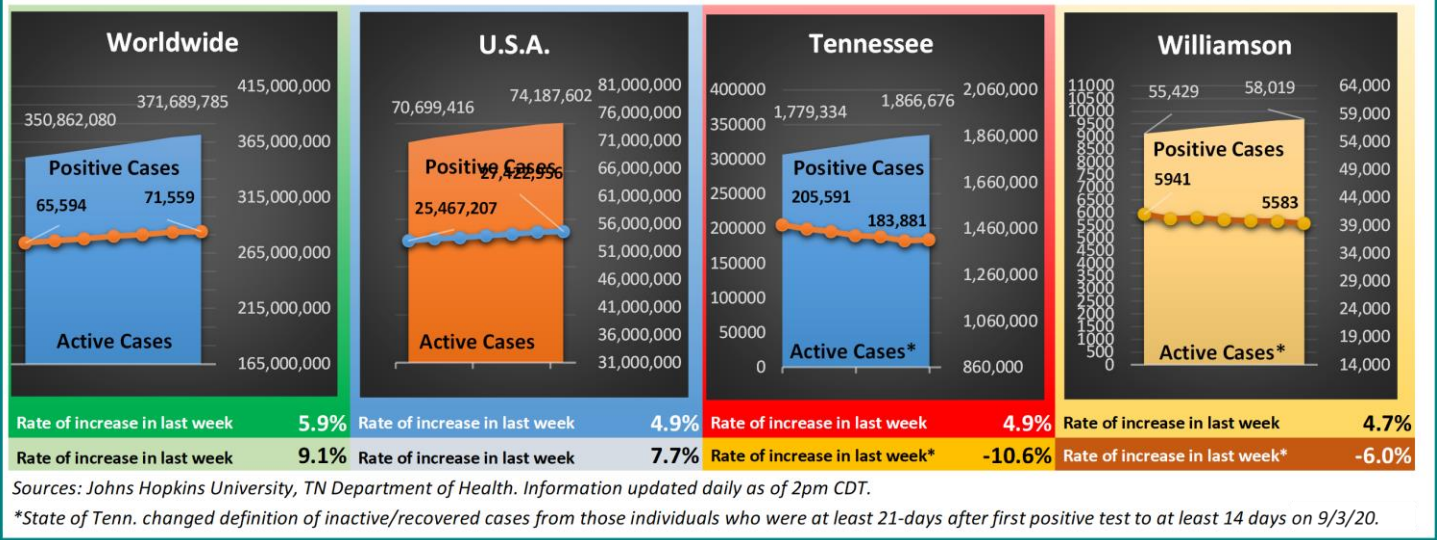
Up Percent Positive / Total Tested at **14.32%**
