In signing this agreement, the above-named grease waste hauler company agrees to the following requirements:

1. The grease waste hauler company agrees that all grease interceptors and grease traps serviced, pumped, or cleaned by the grease waste hauler company in Franklin, TN will be complete pump of all contents (full pump). This includes FOG, food solids and water portion of the interceptor or trap.
2. The grease waste hauler company agrees to provide a manifest or record of grease interceptor or grease trap pumping to the food service establishment, and the information will include, at a minimum: name of food service establishment, address of food service establishment, date pumped, time pumped, volume pumped (in gallons), and final disposal location of the FOG waste pumped
3. The grease waste hauler company agrees to allow the City of Franklin, or their authorized representative, to conduct pumping records audits and final disposal location records reviews. The final disposal location of the FOG wastewater pumped from the City of Franklin food service establishments' grease interceptors or grease traps will be:

4. The grease waste hauler company agrees to have personnel, which will be conducting the grease control equipment cleaning, attend a GCE certification class or web on-line class <https://greasetrapclass.com/> and pass a Metro Water Services grease control equipment (GCE) certification class.
5. The grease waste hauler company shall promptly provide written documentation to the food service establishment's management and to the City of any problems or defects found in the grease interceptor or grease trap. At a minimum, the written notification shall be made for missing inlet or outlet Tees, holes or cracks, deterioration of the equipment, overflowing FOG at outlet Tee, no access to all interceptor chambers, or any obvious problems with the interceptor or trap.
6. The grease waste hauler company agrees to provide the City of Franklin a list of all food service establishments that were pumped or cleaned monthly and provide grease control equipment certification "pass" or "fail" results monthly. The GWH Monthly Pump and grease control equipment certification report will include the food service establishment's name, the food service establishment's address, date pumped, volume pumped, FOG waste disposal location, was a grease trap or grease interceptor certification completed, and did grease trap or grease interceptor certification pass or fail. If a grease trap or grease interceptor certification fails, the grease waste hauler company will send the certification to the City of Franklin. The Grease Waste Hauler Monthly Report will be due by the 15th day of the following month. The grease waste hauler company agrees to use the Franklin EXCEL spreadsheet monthly report form. The Franklin GWH Monthly Report form is attached, and the first month for reporting is March 2022, due by April 15, 2022. The Franklin GWH Monthly Report will be emailed each month to:

7. The Grease Waste Hauler agrees that failure to comply with any of the above agreements will result in the removal of the Grease Waste Hauler from the Franklin Approved Grease Waste Hauler List for a minimum of 2 years, and/or other enforcement action.
