You are receiving this letter to provide public notice of an upcoming Virtual Neighborhood Meeting for a proposed Development Plan and Rezoning for the property located at Map 063, Parcel 04900 at 200 Eddy Lane in Franklin, TN. The Development Plan will include 260 units which will be made up of apartments and affordable units and +/- 10,000 square feet of office space. The meeting will be held on Tuesday, April 5, 2022 at 6:00 pm CST, and you are invited to join the virtual Zoom Meeting:

Why are you receiving this letter?

The proposed project is within 500' of your property.

What is the purpose of the meeting?

The purpose of the meeting is to make citizens aware of a potential new development within your immediate vicinity and allow you to engage with the applicant early in the review process. The meeting is meant to be informative and provide an opportunity to ask questions directly to the developers about the project. If the project continues with a formal application to the city, it will go through a Public Hearing process. Please be aware that Public Hearings do **not** involve a question and answer session.

Will the project be voted on at this meeting?

No. The neighborhood meeting is for informational purposes only. The project, should the applicant continue with a formal application, will be reviewed by the Franklin Municipal Planning Commission (FMPC) on Thursday, May 26, 2022. The FMPC meeting will be publicly noticed and will include time for citizens to speak to the project at formal Public Hearing sessions.

6:05 – 6:35 pm	formal presentation by the applicant to discuss the main points of the plan
6:35 – 6:55 pm	question and answer time; citizens will ask questions within the forum so all in attendance can hear and/or read each question

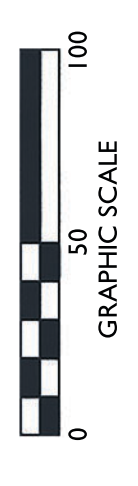
