

RESOLUTION 2019-68

**A RESOLUTION TO ADOPT THE PROJECT LIST FOR THE FY 2019-2028 CIP
(CAPITAL INVESTMENT PROGRAM)**

WHEREAS, the Board of Mayor and Aldermen (BOMA) has determined that the FY 2019-2028 Capital Investment Program (CIP) as has been presented represents their intent as to the capital projects needing to be accomplished within the next several years; and

WHEREAS, the BOMA has reviewed the FY 2019-2028 CIP and ranked its top priority projects for consideration of funding; and

WHEREAS, the BOMA has provided adequate funding capacity for these projects through a variety of sources, including the Invest Franklin initiative; and

WHEREAS, City Staff has recommended and presented to the BOMA the FY 2019-2028 Capital Funding Model for consideration inclusive of many internal and external sources that can be leveraged to fund the projects itemized below to maximize available funding.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF FRANKLIN, TENNESSEE, that the following FY 2019-2028 CIP projects be approved for funding for the approximate amounts shown below utilizing funding as recommended by City Staff:
