  - o To be a *Mentee* you need to have been employed at the City for at least six months.
  - To be a *Mentor* you should have at least three years of leadership experience, not necessarily at the City of Franklin or previously completed the City of Franklin Mentorship Program as a mentee.

- Supervisor approval is required. Be sure you get their signature on your application for whichever role you apply for.
- Turn in applications to the HR office on or before October 17th.

Congratulations to Police Sergeant Mike Stephens for being named "Officer of the Year" by the National Alliance on Mental Illness (NAMI) **Tennessee**, the State's leading mental health advocacy organization! SGT Stephens was honored for his efforts in training more than 100 law enforcement and emergency personnel how to safely and effectively respond to individuals in a mental health crisis. Kim Rush-King, statewide coordinator for the Crisis Intervention Team (CIT) for NAMI Tennessee says: "His colleagues describe him as a respectful and compassionate person who conveys a message of empathy to individuals living with the challenges of a mental health condition in their life. Whether he is de-escalating a situation with respect and compassion, or sharing his knowledge of CIT with others, it is clear he believes wholeheartedly in this program and is eager to share his knowledge and help others." Through Stephens' efforts, all patrol officers and patrol sergeants in the Franklin Police Department are trained in CIT. Additionally, his work in developing a training program in Williamson County made it possible for patrol officers and emergency personnel from the Williamson County Sheriff's Office and police departments in Spring Hill, Brentwood, and Nolensville to also receive CIT training. Thank you, Sgt Stephens, for what you do!
