
Last night, our new Municipal Court Judge Jessica Borne was sworn in by our outgoing Judge Deana Hood. Thank you to Judge Hood who served the City for 8 years. We wish her the best in her Circuit Court Judge position. Judge Borne will preside over City Court which is responsible city ordinance, building code, and traffic violations. Court is held every second and fourth Tuesday and second Thursday of each month at City Hall. Borne was chosen out of 19 candidates for the position. Borne is employed by Fort, Holloway & Rogers. Prior to that, she spent 12 years with the Tennessee Office of the District Attorney General 21st Judicial District, serving Williamson, Lewis, Hickman and Perry Counties. She has dedicated the

last 10 years of her career working with domestic abuse victims and their families by prosecuting and trying criminal cases involving domestic partners. Judge Borne is a native of Atlanta, Georgia but came to Tennessee in 2001 to attend Middle Tennessee State University and to play college soccer. While at MTSU, Jessica obtained her a B.S. and Master's degree in Criminal Justice. She also got her Doctor of Jurisprudence (J.D.) from Nashville School of Law in 2011. Jessica lives in Franklin with her husband and three children.



This week, the Franklin Fire Department's Behavioral Health and Wellness team, comprised of Captain Greg Wild and Engineer Emily Nelms, concluded the introductory training to the department's innovative new program. Over the past several weeks, Engineer Nelms, who has an M.A in Human Services Counseling, Trauma and Crisis Response, and Captain Wild presented the program to nearly 200 people during 14 different training sessions. It includes several components and levels of support, including peer support, EAP, professional counseling, spiritual, educational, substance use support, treatment centers, crisis support, and home support.

The City of Franklin is working with Tennessee Department of Transportation (TDOT) and the City's contractor, Civil Constructors, to speed up the completion date of the Franklin Road project. **From September 6th - 23rd, the southbound lane between Liberty Pike and First Avenue will be closed.**The northbound lane of Franklin Road will remain open for the duration. This Franklin Road lane closure and detour will allow Civil Constructors to perform expedited roadway grading and paving on



both the current Franklin Road southbound lane and new center turn lane (between the Harpeth River bridge and Liberty Pike). With the ability for the contractor to work concurrently on both southbound and center turn lanes, by implementing this extended lane closure and detour, Civil estimates a project schedule acceleration of 4 weeks. This approved lane closure/detour, and 4-week project schedule acceleration, will move the paving operation earlier into November 2022. This would hopefully prevent the need for a cold weather paving plan or having to wait until Spring 2023 for final paving. Southbound Franklin Road traffic will be detoured at Mack Hatcher to Hillsboro

Road. Local traffic will be allowed from Mack Hatcher to Liberty Pike. Full access will be available to Harlinsdale Farm and the Factory.
