You are receiving this letter to provide public notice of an upcoming Virtual Neighborhood Meeting for a proposed Development Plan located at Map 079, Parcels 03900 and 03901 at 1312 and 1316 Huffines Ridge Drive in Franklin, TN. The applicant is proposing a mixed-use Development Plan with 7,500 square feet of commercial uses and 375 multi-family units – including a public plaza, pool, amenity courtyard, dog park and structured parking. The meeting will be held on Thursday, February 2, 2023 at 5:00 pm CST, and you are invited to join the virtual Zoom Meeting:

Why are you receiving this letter?

The proposed project is within 500' of your property.

What is the purpose of the meeting?

The purpose of the meeting is to make citizens aware of a potential new development within your immediate vicinity and allow you to engage with the applicant early in the review process. The meeting is meant to be informative and provide an opportunity to ask questions directly to the developers about the project. If the project continues with a formal application to the city, it will go through a Public Hearing process. Please be aware that Public Hearings do **not** involve a question and answer session.

Will the project be voted on at this meeting?

No. The neighborhood meeting is for informational purposes only. The project, should the applicant continue with a formal application, will be reviewed by the Franklin Municipal Planning Commission (FMPC) on Thursday, March 23, 2023. The FMPC meeting will be publicly noticed and will include time for citizens to speak to the project at formal Public Hearing sessions.
