SUBJECT: Consideration of bid award to Component Fabricators, d/b/a Legend Fitness, of Maynardville, TN

in the amount of \$30,150.00 for supply, delivery and installation of fitness equipment for the

Police Department (Purchasing Office Procurement Solicitation No. 2010-038)

Purpose

The purpose of this procurement is to equip the new Franklin Police Department headquarters with fitness equipment for use by employees of the department. This new fitness equipment would be installed at this location instead of moving the department's existing equipment so that the existing equipment could be left in place at City Hall and available for use by all employees of the City.

Background

The Board of Mayor and Aldermen has discussed this issue previously.

Financial Impact

The City published on June 10, 2010 a Notice to Bidders in the *Williamson Herald* for the supply, delivery and installation of fitness equipment. In addition, bid documents were sent on or about the same date directly to seven (7) potential bidders known or thought to be interested in this solicitation. Bids from three (3) vendors were publicly opened at the bid opening held on June 24, 2010. A tabulation of the bids received for this solicitation is attached. The apparent lowest, most responsive and responsible bid, from Component Fabricators, d/b/a Legend Fitness, of Maynardville, TN, is in the total amount of \$30,150.00 for supply, delivery and installation of the specified quantities and types of equipment. This bid was identified because it is the lowest bid that most closely meets or exceeds the City's intention as expressed and implied by the City's specifications as well as the instructions, terms and conditions pertaining to this procurement solicitation. It is worth noting that both of the other bids were incomplete as they each failed to include all of the documentation required by the City.

Options

In accordance with the bid documents, the City reserves the right to reject any and all bids.

For financing this purchase, the City has the following two options:

- 1. Pay for the purchase now as an expense to be allocated to the Police Headquarters construction project.
- 2. Pay for the purchase over time by means of the City's master lease agreement already in place which has some remaining capacity that could be used for the fitness equipment. This would involve a commitment to pay approximately \$6,700 per year for five years, with payments to be allocated to the Police Department operating budget.

Recommendation

Staff recommends:

- 1. That the City accept the apparent lowest best bid, from Component Fabricators, d/b/a Legend Fitness, of Maynardville, TN, in the total amount of \$30,150.00 for supply, delivery and installation of the specified quantities and types of equipment. Purchasing Manager Brian Wilcox is of the opinion that the prepared specifications as distributed allowed for competition among multiple vendors, and that the staff recommendation appears to be made in a fair and impartial manner based upon the bids received.
- 2. That the purchase be paid for now as an expense to be allocated to the Police Headquarters construction project.
