

## **Strategic Planning Work Continues!**



The **Board of Mayor and Alderman** and the **Leadership Team** rolled up their sleeves and spent two long evenings this past Monday and Tuesday further refining and working on the **City's new, updated Strategic Plan.** This plan will cover strategic goals for the next 10 years and have 1–3-year measurable action outcomes ("deliverables") that will guide our City team in our work. Begun in January and led by our consultant Cory Plasch, the work achieved during our two-evening strategic plan "retreat" took us from a Vision and Values statement to working on Mission, and Strategic Issues and finished with six Strategic Goal areas with three outcomes apiece. The next piece of this process will be for the **Office of Budget and Performance Team** to refine those measures with departments and then provide the opportunity for employees to review the progress and provide feedback. Stay tuned for that opportunity in late summer/early fall. **We hope to have a new Strategic Plan in place around the first of the year and ready to implement in the FY 2026 Budget.**
